Chairman's Statement 主席報告

Dear Shareholders,

On behalf of the Board, I am pleased to present the Company's annual results for the year ended 31 March 2023.

Despite the challenges faced during the past year, I am proud to report that our company has continued to navigate the challenging business landscape with resilience and adaptability.

With the Covid-19 pandemic continued to severely affect the Hong Kong lifestyle entertainment industry generally, this past year has been a difficult time for our lifestyle entertainment business in Hong Kong. This segment continued to experience a downturn in performance as social restrictions and cautious consumer behavior exhibited during the pandemic hindered our operations. Furthermore, despite the gradual lifting of various social restrictions since November 2022, the recovery of the Hong Kong market post COVID-19 has been slower than initially anticipated.

While our lifestyle entertainment business continued to experience downturn in performance after implementing various cost-cutting measures and adapting new business strategies, it is fortunate that our decision to diversify into the property management sector several years ago has paid off. Throughout this challenging period, the performance of our property management segment has remained strong consistently, showcasing our resilience and strength in this sector.

As a result, even with a drop in the revenue from our lifestyle entertainment segment by 27.9% as compared with last year, with our property management segment remaining strong, our revenue has continued to grow and we achieved a turnaround in net results from a net loss of HK\$0.1 million to a net profit of HK\$24.1 million this year.

The Group's revenue increased by approximately 11.2% to approximately HK\$397.1 million for the year ended 31 March 2023. The revenue growth was mainly driven by a 13.8% increase in revenue from our property management segment.

各位股東:

本人謹代表董事會欣然提呈本公司截至二零二三年三月三十一日止年度之年度業績。

儘管在過去一年中面對挑戰,本公司仍能繼續 憑藉其抗逆力及適應力應對充滿挑戰的業務環境,對此我引以為傲。

由於COVID-19疫情持續影響香港整個生活娛樂行業,過去一年對我們在香港的生活娛樂業務而言屬困難時刻。由於疫情期間所實施的社交限制及所造成的謹慎消費態度均妨礙我們的營運,以致該分部業績繼續下滑。此外,儘管自二零二二年十一月起各類社交限制已逐步放寬,但香港市場在COVID-19疫情過後的復甦速度仍比預期慢。

雖然我們的生活娛樂業務在實施各種成本削減措施及調整新的業務策略後業績仍然下跌,但慶幸我們在數年前決定進軍物業管理行業的多元化發展已初見成效。在該段嚴峻時期,我們的物業管理分部的表現仍然持續強勁,足以展現我們在該行業的抗逆力及實力。

因此,儘管我們的生活娛樂分部收入較去年下降27.9%,但我們的物業管理分部依然強勁,收入持續增長,令我們的業績淨額轉虧為盈,由虧損淨額100,000港元轉至今年錄得利潤淨額24,100,000港元。

截至二零二三年三月三十一日止年度,本集團收益增加約11.2%至約397,100,000港元。收益增長主要由我們的物業管理分部收益增加13.8%帶動。

Chairman's Statement 主席報告

Revenue from our property management services has increased by HK\$47.9 million from HK\$328.2 million last year to HK\$376.1 million for the year ended 31 March 2023. The growth was mainly driven by the value-added services introduced in the past year, which generated HK\$56.4 million in revenue for the segment. In addition to this new growth factor, our property management segment continued its improvement in project portfolio, and our total GFA under management has increased from 8.68 million sq. m last year as compared to 9.0 million sq. m this year.

In relation to our lifestyle entertainment segment, there was a decline in revenue by HK\$8.1 million, representing a decrease of 27.9% from HK\$29.1 million last year to HK\$21.0 million this year. Acknowledging the evolving consumer preference that appears to be veering away from nightlife entertainment, we implemented new marketing strategies, such as expanding our music categories from electronic dance music to include hip hop music to enhance our allure to our valued customers during the year ended 31 March 2023. However, even with the lifting of travel restrictions, the local economy has yet to move towards full recovery, and our clubbing business encountered formidable competition from overseas entertainment attractions and more affordable leisure alternatives.

我們的物業管理服務收益由去年328,200,000港元增加47,900,000港元至截至二零二三年三月三十一日止年度376,100,000港元。該增幅主要有賴於去年引入的增值服務,其為該分部帶來56,400,000港元收入。除上述帶動增長的因素外,我們的物業管理分部亦會繼續改善其項目組合,而我們所管理的總建築面積由去年8,680,000平方米增加至本年度9,000,000平方米。

就生活娛樂分部而言,其錄得收益減少8,100,000港元,由去年29,100,000港元減少27.9%至本年度21,000,000港元。了解到消費者的喜好不斷轉變,開始逐漸遠離夜生活娛樂,因此我們於截至二零二三年三月三十一日止年度實施新的營銷策略(例如將我們的音樂類別由電子舞曲增加至包括嘻哈音樂),以增加對客戶的吸引力。然而,即使旅遊限制已取消,但本地經濟尚未走向全面復甦,我們的夜店業務遇到來自海外娛樂場所及更實惠的消遣活動的激烈競爭。

OUTLOOK

The Group's property management business continued to be recognised by the market for the quality of its services. Ningbo AUX continued to improve its ranking in 2022 China's Top 100 Best Property Management Service Companies from 35th last year to 33rd in 2023. In addition to the advancement in the above ranking, Ningbo AUX was also awarded the Management Excellence in Hospital Premises China 2023 and 2022 Zhejiang Province Property Service AAA Credit Enterprise award in the same year. These awards encourage Ningbo AUX to continue enhancing its brand awareness and service quality.

Building on the success of its valued-added services, Ningbo AUX will allocate more resources to identify and evaluate new opportunities in this area, aiming to inject additional growth momentum into our business.

展望

本集團物業管理業務的服務質素持續獲得市場認可。寧波奧克斯於二零二二年中國首百名最佳物業管理服務公司的排名持續提升,由去年第35位上升至於二零二三年的第33位。除上述排名上升外,寧波奧克斯於同一年亦榮獲二三年中國醫院物業優秀管理獎及二零二二年中國醫院物業服務AAA級信用企業。上述獎預推動寧波奧克斯繼續提高品牌知名度及服務質素。

基於增值服務的成功,本集團將分配更多資源來識別和評估該領域新的機遇,旨在為我們業務注入額外的增長動力。

Chairman's Statement

Although the impact of the COVID-19 outbreak in Hong Kong is subsiding, its influence on consumer behavior, such as the decreasing trend in demand for nightlife entertainment, remains. Furthermore, the recovery in the Hong Kong economy has been slower than expected, resulting in a weakened purchasing power in general. Given these circumstances, the Group maintains a cautious outlook on the future performance of its our lifestyle entertainment segment and will continue to evaluate its contribution to the Group from time to time.

儘管香港的COVID-19疫情影響已逐漸消退,但 對消費者行為造成的影響(例如他們對夜生活 需求下降的趨勢)依然存在。此外,香港經濟復 甦不如預期,導致整體購買力減弱。有鑑於此, 本集團對生活娛樂業務的未來表現仍然保持審 慎並將不時評估該業務對本集團的貢獻。

Our commitment to our shareholders and stakeholders remains unwavering. We are focused on enhancing shareholder value and delivering sustainable long-term growth. We will continued to prudently manage our resources, optimize our operations, and pursue prudent investment opportunities to create value for our shareholders.



Management Discussion and Analysis 管理層討論與分析

OVERALL PERFORMANCE

During the year ended 31 March 2023 (the "Year"), our lifestyle entertainment business in Hong Kong has faced significant challenges due to the COVID-19 pandemic. Like many sectors in Hong Kong, our lifestyle entertainment business has been severely impacted by the pandemic. The implementation of social restrictions and cautious consumer behavior has hindered the lifestyle entertainment business operations, leading to a downturn in performance. While social restrictions have been gradually lifted since November 2022, the recovery of the Hong Kong market after the COVID-19 pandemic has been slower than expected. As a result, our lifestyle entertainment business continues to experience a decline in performance.

While our lifestyle entertainment business's performance did not live up to expectation, our property management business in China has remained a strong contributor to the Group during this challenging period.

Ningbo AUX Property Management Service Co., Ltd ("Ningbo AUX") continued to improve its portfolio and expanded its business scope to provide value-added services during the Year. Compared to the year ended 31 March 2022 ("FY21/22"), the number of projects managed by the Group as of 31 March 2023 has increased from 65 projects to 66 projects, while the aggregate contracted gross floor area increased from 8.68 million sq.m. to 9.0 million sq.m.

The revenue from property management services and its related value-added services increased by HK\$47.9 million, from HK\$328.2 million in FY21/22 to HK\$376.1 million in the Year. This growth was primarily due to the introduction of the value-added services, which generated approximately HK\$56.4 million in revenue for the segment.

As a result, even with the decrease in revenue from our lifestyle entertainment segment by 27.9% compared to FY21/22, the Group's revenue for the Year increased by approximately 11.1% to approximately HK\$397.1 million.

整體表現

截至二零二三年三月三十一日止年度(「本年度」),我們在香港的生活娛樂業務因COVID-19疫情而面臨重大挑戰。與香港的眾多行業一樣,我們的生活娛樂業務亦受到疫情嚴重打擊。所實施的社交限制及謹慎的消費行為影響生活娛樂業務營運,導致業績下跌。儘管自二零二二年十一月以來社交限制逐漸解除,但COVID-19疫情過後香港市場的復甦速度仍比預期慢。因此,我們的生活娛樂業務業績仍繼續出現下跌。

雖然我們的生活娛樂業務表現未如預期,但我 們在中國的物業管理業務在此充滿挑戰的時期 仍然為本集團帶來巨大貢獻。

寧波奧克斯物業服務有限公司(「寧波奧克斯」) 本年度繼續改善項目組合及擴大業務範圍, 以提供增值服務。相對於截至二零二二年三 月三十一日止年度(「二零二一/二二財政年 度」),本集團於二零二三年三月三十一日管理 的項目數目由65項增加至66項,而總合約建築 面積則由8.68百萬平方米增加至9.0百萬平方米。

物業管理服務及其相關增值服務的收益由二零二二年財政年度的328.2百萬港元增加47.9百萬港元至本年度的376.1百萬港元。該增幅主要有賴於所推出的增值服務,其為該分部帶來收益約56.4百萬港元。

因此,儘管生活娛樂分部的收益較二零二一/二二財政年度減少27.9%,本集團本年度的收益增加約11.1%至約397.1百萬港元。

Management Discussion and Analysis 管理層討論與分析

In line with the property management services segment's expansion in business scope, the Group's cost of inventories sold has increased by HK\$53.6 million to HK\$61.3 million for the Year.

隨著物業管理服務分部的業務範圍擴大,本集團本年度的已售存貨成本增加53.6百萬港元至61.3百萬港元。

In response to the COVID-19 pandemic, the Group's property management services segment allocated substantial human resources to implement and manage various preventive measures in FY21/22. As the pandemic situation has gradually improved during the Year, the high demand for manpower has decreased. As the Group decided not to pursue the photovoltaic products business, it further decreased the level of human resources employed by the Group. As a result, staff costs for the Group decreased by HK\$17.2 million, amounting to HK\$141.3 million for the Year.

為應對COVID-19疫情,本集團的物業管理服務分部於二零二一/二二財政年度分配大量人力資源以實施及管理各項防預措施。隨著本年度疫情逐漸緩和,對人力資源的高需求有所減少。由於本集團決定不再發展光伏產品業務,因此進一步降低本集團所僱用的人力資源水平。因此,本年度本集團員工成本減少17.2百萬港元至141.3百萬港元。

The Group's lifestyle entertainment segment recorded an impairment loss on property, plant, and equipment of HK\$13.1 million resulting from the negative impact caused by the COVID-19 pandemic and the slower-than-expected recovery after the pandemic.

本集團的生活娛樂分部錄得物業、廠房及設備減值虧損13.1百萬港元,此乃由於COVID-19疫情造成的負面影響及疫情後復甦速度比預期慢所致。

In addition, the Group generated a net exchange gain of HK\$7.3 million in respect of the loan from a controlling shareholder denominated in Renminbi ("RMB") as a result of the depreciation of Renminbi against Hong Kong dollars for the Year.

此外,由於本年度人民幣兑港元貶值,本集團以 人民幣(「人民幣」)計值的控股股東貸款產生匯 兑收入淨額7.3百萬港元。

As a result, the Group achieved a turnaround in net results, transitioning from a net loss of HK\$0.1 million to a net profit of HK\$24.1 million during the Year.

因此,於本年度,本集團的業績淨額轉虧為盈, 由錄得虧損淨額0.1百萬港元轉為錄得溢利淨額 24.1百萬港元。

OPERATING COSTS

營運成本 _{昌工成本}

Staff Costs

員工成本包括薪金、工資、酌情花紅、會籍佣金、分配予員工來自客戶的小費及其他福利,其中包括退休福利成本及應支付予長期及兼職員工的其他津貼及福利。員工成本由二零二一/二二財政年度約158.5百萬港元減少17.3百萬港元(即10.9%)至本年度約141.3百萬港元。該減幅主要由於COVID-19疫情導致人力資源需求減少,令物業管理服務分部產生的員工成本有所下降所致。而本年度結束光伏業務也導致員工成本下降。

The staff costs comprised salaries, wages, discretionary bonuses, membership commissions, tips from customers allocated to staff and other benefits including retirement benefit costs and other allowances and benefits payable to permanent and part time staff. The staff costs decreased by HK\$17.3 million, representing 10.9%, to approximately HK\$141.3 million for the Year from approximately HK\$158.5 million for FY21/22. The decrease was mainly due to decrease in staff costs incurred from the property management services segment as the demand for human resources derived from the COVID-19 pandemic has decreased. The close down of photovoltaic product business during the Year also resulted in decrease in staff costs.

Utilities Expenses and Repair and Maintenance Expenses

The utilities expenses and repair and maintenance expenses remained stable, representing an increase at approximately HK\$0.3 million or 1.0% for the Year.

Other Operating Expenses

The other operating expenses increased by approximately HK\$6.1 million to HK\$40.6 million, representing an increase of 17.7%, for the Year (FY21/22: approximately HK\$34.5 million). Such expenses included gardening costs, security costs and other miscellaneous expenses. The increase was mainly due to the impairment losses on trade receivables.

LIQUIDITY, FINANCIAL RESOURCES AND GEARING

As at 31 March 2023, the Group's total current assets and current liabilities were approximately HK\$380.3 million (31 March 2022: approximately HK\$430.3 million) and approximately HK\$234.6 million (31 March 2022: approximately HK\$318.8 million) respectively, while the current ratio was about 1.6 times (31 March 2022: 1.3 times).

As at 31 March 2023, the Group maintained cash at bank and in hand of approximately HK\$286.4 million (31 March 2022: approximately HK\$330.2 million). In the foreseeable future, the Group expects to fund its capital expenditures, working capital and other capital requirements from cash generated from its operations and other financing means which the Company may from time to time consider appropriate.

Total interest-bearing borrowing of the Group as at 31 March 2023 was approximately HK\$68.6 million (31 March 2022: HK\$102.1 million), which was comprised mainly of the non-current portion of HK\$52.4 million of the loan with a term of three years at an interest rate of 2% per annum granted by the controlling shareholder of the Company to Starry Chance Limited, an indirect wholly-owned subsidiary of the Company, for the purpose of financing its acquisition of the entire equity interests in Ningbo AUX. The gearing ratio, which is calculated by dividing total interest-bearing borrowings by total equity, as at 31 March 2023 was 0.3 (31 March 2022: 0.4).

水電費以及維修及維護開支

本年度,水電費以及維修及維護開支保持穩定,維持在增加約0.3百萬港元(或1.0%)。

其他經營開支

本年度,其他經營開支增加約6.1百萬港元(即 17.7%)(二零二一/二二財政年度:約34.5百萬港元)至40.6百萬港元。該等開支包括園藝成本、保安成本及其他雜項費用。該增幅乃主要由於貿易應收款項減值虧損導致。

流動資金、財務資源及資產負債

於二零二三年三月三十一日,本集團之總流動資產及流動負債分別為約380.3百萬港元(二零二二年三月三十一日:約430.3百萬港元)及約234.6百萬港元(二零二二年三月三十一日:約318.8百萬港元),而流動比率約為1.6倍(二零二二年三月三十一日:1.3倍)。

於二零二三年三月三十一日,本集團之銀行存款及現金為約286.4百萬港元(二零二二年三月三十一日:約330.2百萬港元)。本集團預期於可見將來透過經營活動及本公司可能不時認為恰當之其他融資方式的所得現金以撥付其資本開支、營運資金及其他資本需求。

本集團於二零二三年三月三十一日的總計息借款為約68.6百萬港元(二零二二年三月三十一日:102.1百萬港元)。該計息借款包括本公司的股股東提供予寶星有限公司(本公司的一間間接全資附屬公司)的為期三年按年利率2%計息的貸款的非即期部份52.4百萬港元。該筆貸款是為資助收購寧波奧克斯的全部股權。於二零二三年三月三十一日,按總計息借款除以總權益計算之資產負債比率為0.3(二零二二年三月三十一日:0.4)。

CAPITAL STRUCTURE

On 26 October 2021, the Company entered into a subscription agreement with Huiri Limited (the "Subscriber"). Pursuant to the subscription agreement, the Company has conditionally agreed to allot and issue and the Subscriber has conditionally agreed to subscribe for 118,000,000 shares (the "Subscription") at the price of HK\$0.63 per share for a consideration of HK\$74,340,000. All the conditions set out in the subscription agreement have been fulfilled and accordingly, the completion of the Subscription took place on 15 February 2022. The net proceeds from the Subscription, after deduction of the related expenses, of approximately HK\$73,730,000 were intended to be applied for working capital, rental expenses of the lifestyle entertainment segment and partial repayment of the loans from the controlling shareholder.

The Group manages its capital to safeguard the Group's ability to continue as a going concern while maximising the return to shareholders through maintaining the equity and debt in a balanced position.

As at 31 March 2023, the capital structure of the Group consisted of equity of approximately HK\$232.0 million (31 March 2022: approximately HK\$243.9 million) and loans from the controlling shareholder of approximately HK\$74.4 million (31 March 2022: HK\$110.9 million). Except for the loans from the controlling shareholder (non-current portion) and lease liabilities, the Group had no interest-bearing bank borrowings, debt securities or other capital instruments as at 31 March 2023.

The Group intends to conduct more in-depth reviews on the suitable development strategies for the Group, including the feasibility of diversifying the income stream of the Group by exploring different business and investment opportunities in different business areas such as trading, property management, internet information technology and other industries, which may or may not include any assets and/or business acquisitions or disposals by the Group, and will consider all options. Any such plans will be subject to review and approval by the Board and compliance with the applicable requirements under the Listing Rules where appropriate. The costs of any such acquisitions will be met with cash generated from the operations of the Group and other financing means which the Group may consider appropriate from time to time.

FOREIGN EXCHANGE EXPOSURE

The Group operates in Hong Kong and Mainland China and is exposed to foreign exchange risks arising from RMB. Foreign exchange risks arise from future commercial transactions, recognised assets and liabilities denominated in RMB for the entities with a functional currency in Hong Kong dollars. The Group did not use any forward contracts to hedge its foreign currency exposure during the Year. The Group will from time to time review and adjust its hedging and financial strategies based on exchange rate movements in RMB and Hong Kong dollars.

CONTINGENT LIABILITIES

As at 31 March 2023, the Group did not have any material contingent liabilities.

EMPLOYEE AND REMUNERATION POLICY

As at 31 March 2023, the Group employed approximately 994 employees (31 March 2022: 1,089 employees). The Group offers competitive remuneration packages to its staff, including share option scheme, mandatory provident fund scheme and discretionary bonus.

PROSPECTS

The Group is dedicated to driving sustainable growth and delivering value to its stakeholders. To achieve this goal, the Group closely monitors market developments and reviews our business strategy regularly and with an open mindset to seize favorable investment opportunities to drive sustainable growth.

While the COVID-19 pandemic is now behind us, the Group remains cautious regarding the outlook of its lifestyle entertainment segment due to the weaker-than-anticipated economic recovery. We recognise that the pandemic has, to a certain extent, brought about changes in the lifestyle, habits and consumption patterns of local residents and visitors and the effect may be lingering, which may hinder the recovery of the nightlife entertainment industry. On the other hand, our property management business has shown stronger resilience in the past years, which indicates a bigger potential for future growth.

As we navigate these dynamics, the Group is actively exploring ways to optimise its resource allocation and operations, where focus will be put on our property management business, which has proved to be profit-making, to maximise shareholder value and ensure the long-term stability and profitability of the Group.

Lifestyle entertainment segment

To adapt to the changes in consumer behavior, the Group will emphasise cost-consciousness and carefully allocate resources to strategies that benefit the Group. We are committed to enhancing operational efficiency and streamlining procedures to maximize productivity and minimize costs in the lifestyle entertainment segment.

Property management segment

The Group's property management segment has demonstrated consistent growth in revenue in the past years. We will continue to build upon this success by further strengthening our brand reputation and seeking opportunities to provide more value-added services to our customers, diversifying and enriching our income portfolio.

The Board does not recommend the payment of a final dividend for the year ended 31 March 2023 (31 March 2022: nil).

The Board is of the opinion that the Company has complied with all the applicable code provisions as set out in the Corporate Governance Code (the "CG Code") contained in Appendix 14 to the Rules Governing the Listing of Securities on the Stock Exchange (the "Listing Rules") for the year ended 31 March 2023.

The Company has adopted The Model Code for Securities Transactions by Directors of Listed Issuers (the "Model Code") as set out in Appendix 10 to the Listing Rules as the code of conduct for securities transactions by the Directors. The Company has made specific enquiries with all Directors and they have confirmed that they have complied with the Model Code throughout the year ended 31 March 2023.

The Board provides leadership, guidance and strategic decisions to the Group's activities and oversees its financial performances. The Board has delegated its powers to the management for the Group's daily management and operations.

During the year ended 31 March 2023, the Board comprised four executive Directors and three independent non-executive Directors. At least one of the independent non-executive Directors possessed the appropriate professional accounting qualifications and financial management expertise, which complied with the requirements of the Listing Rules. The Board has established the Audit Committee, the Remuneration Committee and the Nomination Committee. All Board committees perform their distinct roles in accordance with their respective terms of reference which are available to shareholders on the websites of the Company and the Stock Exchange. The Board committees are provided with sufficient resources to discharge their duties and, upon reasonable request, are able to seek independent professional advice in appropriate circumstances, at the Company's expense.

Audit Committee

The Audit Committee was established on 3 January 2014 with terms of reference in compliance with the CG Code. For the year ended 31 March 2023, the Audit Committee comprised three members, namely Mr. Bau Siu Fung (Chairman), Mr. Poon Chiu Kwok and Ms. Lou Aidong, all being independent non-executive Directors.

The primary responsibilities of the Audit Committee include, among others, (i) providing an independent view of the effectiveness of the financial reporting process, internal control, compliance and risk management systems of the Group; (ii) overseeing the audit process and performing other duties and responsibilities as assigned by the Board; (iii) developing and reviewing the policies and practices on corporate governance with legal and regulatory requirements and requirements under the Listing Rules; and (iv) developing, reviewing and monitoring the code of conduct applicable to the employees and Directors.



RISK MANAGEMENT AND INTERNAL CONTROL

The Board acknowledges that it is its duty to monitor the risk management and internal control systems of the Group on an ongoing basis and review their effectiveness. Such systems are designed to manage rather than eliminate the risk of failure to achieve business objectives, and can only provide reasonable and not absolute assurance against material misstatement or loss.

During the Year, the Board, through the Audit Committee, conducted an annual review of both design and implementation effectiveness of the risk management and internal control systems of the Group, covering all material controls, including financial, operational and compliance controls, with a view to ensuring that resources, staff qualifications and experience, training programmes and budget of the Group's accounting, internal audit and financial reporting functions are adequate. 年內,董事會透過審核委員會檢討本集團年度 風險管理及內部監控制度的設計及實施成效, 涵蓋所有重大控制,包括財務、經營及合規控制, 旨在確保本集團在會計、內部審核及財務匯報 職能方面之資源、員工資歷及經驗、培訓計劃及 有關預算充足。就此而言,審核委員會就任何重 大事宜會與董事會溝通。

企業管治報告

During the Year, the Group appointed Mazars Risk Advisory Services Limited ("Mazars") to:

- assist in identifying and assessing the risks of the Group through a series of workshops and interviews; and
- independently perform internal control review and assess the effectiveness of the Group's risk management and internal control systems.

The results of the independent review and assessment were reported to the Audit Committee and the Board. Moreover, improvements in internal control and risk management measures as recommended by Mazars to enhance the risk management and internal control systems of the Group and mitigate risks of the Group were adopted by the Board. Based on the findings and recommendations of Mazars as well as the comments of the Audit Committee, the Board considered the internal control and risk management systems are effective and adequate.

The Group has established internal control procedures for the handling and dissemination of inside information in order to comply with Chapter 13 of the Listing Rules as well as Part XIVA of the Securities and Futures Ordinance. The internal control mechanism includes information flow and reporting processes, confidentiality arrangements, disclosure procedures, and staff training arrangements, etc.

Our Enterprise Risk Management Framework

The Group has established its enterprise risk management framework in 2016. While the Board has the overall responsibility to ensure that sound and effective internal controls are maintained, management is responsible for designing and implementing an internal control system to manage all kinds of risks faced by the Group.

Through the risk identification and assessment processes, risks are identified, assessed, prioritised and allocated treatments. Our risk management framework follows the COSO Enterprise Risk Management—Integrated Framework, which allows the Board and management to manage the risks of the Group effectively. The Board receives regular reports through the Audit Committee, which oversees risk management and internal audit functions.

OUR RISK CONTROL MECHANISM

The Group adopts a "three lines of defence" corporate governance structure with operational management and controls performed by operations management, coupled with risk management monitoring carried out by the finance and compliance team and independent internal audit outsourced to and conducted by Mazars. The Group maintains a risk register to keep track of all identified major risks of the Group. The risk register provides the Board, the Audit Committee, and management with a profile of its major risks and records management's action taken to mitigate the relevant risks. Each risk is evaluated at least annually based on its likelihood of occurrence and potential impact upon the Group. The risk register is updated by management as the risk owners with the addition of new risks and/or removal of existing risks, if applicable, at least annually, after the annual risk evaluation has been performed. This review process can ensure that the Group proactively manages the risks faced by it in the sense that all risk owners have access to the risk register and are aware of and alert to those risks in their area of responsibility so that they can take follow-up action in an efficient manner.

The Group's risk management activities are performed by management on an ongoing process. The effectiveness of the Group's risk management framework will be evaluated at least annually, and periodic management meeting is held to update the progress of risk monitoring efforts. Management is committed to ensuring that risk management forms part of the daily business operation processes in order to align risk management with corporate goals in an effective manner.

The Company will continue to engage external independent professionals to review the Group's system of internal controls and risk management annually and further enhance the Group's internal control and risk management systems as appropriate.

There is currently no internal audit function within the Group. The Directors have reviewed the need for an internal audit function and are of the view that in light of the size, nature and complexity of the business of the Group, it would be more cost-effective to appoint external independent professionals to perform internal audit functions for the Group in order to meet its needs. Nevertheless, the Directors will continue to review at least annually the need for an internal audit function.

The Board adopted a dividend policy for the Company which took effect from January 2014. In deciding whether to propose a dividend and in determining the dividend amount, the Board will take into account the Company's future operations and earnings, capital requirements and surplus, general financial condition, contractual restrictions and other factors which the Directors deem relevant such as the prevailing market conditions and global economic situation.

The dividend payout ratio would be calculated based on certain per cent of the net profit recorded during the financial year, with a view to retaining sufficient funds and capital for operational uses and future investment opportunities and ensuring that all possible acquisitions could be properly financed. The dividend policy will continue to be reviewed from time to time and there can be no assurance that dividends will be paid in any particular amount for any given period.

The payment of dividends is also subject to any restriction under the laws of Hong Kong, the laws of the Cayman Islands and the Articles of Association of the Company (the "Articles").

SHAREHOLDERS' RIGHTS

The general meetings of the Company provide an opportunity for communications between the shareholders and the Board. An annual general meeting ("AGM") of the Company shall be held each year and at the place as may be determined by the Board.

The request will be verified with the Company's branch share registrar in Hong Kong and upon their confirmation that the request is proper and in order, the Board will convene an EGM by serving sufficient notice in accordance with the statutory requirements to all the registered Shareholders. On the contrary, if the request has been verified as not in order, the Shareholders will be advised of this outcome and accordingly, an EGM will not be convened as requested. If within 21 days of such deposit, the Board fails to proceed to convene such meeting, the requisitionist(s) himself (themselves) may do so in the same manner, and all reasonable expenses incurred by the requisitionist(s) as a result of the failure of the Board shall be reimbursed to the requisitionist(s) by the Company.

Putting Enquiries by Shareholders to the Board

Shareholders may send written enquiries to the Company for the attention of the company secretary at the Company's headquarters in Hong Kong.

Reporting Principles

In preparing this report, the Group has referred to certain global, local and industrial standards or best practices, including the ESG Reporting Guide of the Stock Exchange and applicable Hong Kong Accounting and Financial Reporting Standards.

STATEMENT BY THE BOARD

The Group recognises the importance of environmental, social and corporate governance for sustainable corporate development and ensures the relevant ESG policies are effectively implemented in its operations. The board of the Group (the "Board") is primarily responsible for monitoring ESG governance issues relating to the Group, and monitoring the formulation and implementation of relevant policies and measures by the management and relevant departments. The Board also requires the Group's management to report to the Board on ESG-related issues and subsequent developments in a timely and proactive manner, such as significant deviations from expected targets in ESG performance indicators, serious ESG incidents, changes in regulatory requirements, etc...

The Board is responsible for:

- appointing the Group's key persons responsible for ESG issues;
- approving ESG strategies, action plans and goals;
- monitoring the progress and performance of ESGrelated measures;
- approving the implementation of ESG-related measures and monitoring the resources required;
- raising appropriate ESG-related questions, inquiries and recommendations to management; and
- reviewing and approving annual ESG reports.

The management is responsible for:

- identifying and assessing the Group's ESG risks and opportunities and report to the Board;
- developing ESG strategies, action plans, goals and arrange relevant work accordingly;
- ensuring appropriate and effective ESG risk management and internal monitoring systems being in place;
- providing guidance for the implementation of ESG policies and measures;
- reporting to the Board on the progress and performance of ESG; and
- reviewing the annual ESG report and submit it to the Board for approval.

董事會聲明

本集團了解環境、社會及企業管治對企業可持續發展之重要性,並確保相關ESG政策在其運營中能有效的實施。本集團董事會(「董事會」)主要負責監督有關本集團的ESG管治事宜,以及監督管理層及相關部門製定及實施相關政策與措施。董事會亦要求集團管理層應及時級時、與措施。董事會匯報ESG之相關事宜和後續設目標、例如出現ESG績效指標大幅度偏離預設目變化等情況。

- preparing the annual ESG report and report to the management.

The Board will continue to monitor the ESG-related work and keep abreast of the latest ESG disclosure requirements and regulations of the HKEx. The Board will also ensure that all departments work closely to achieve the goal of operational compliance and shouldering social responsibility, and set clearer ESG goals for the Group in the future to better meet the expectations of stakeholders.

The Group actively seeks every opportunity to understand our stakeholders, and guarantees the regular improvement of our services. We firmly believe that our stakeholders play a vital role in maintaining the success of our business.



MATERIALITY ASSESSMENT

During the financial year of 2022/2023, the Group conducted surveys of internal and external stakeholders, including management, employees, major customers and major suppliers, to identify and assess material ESG issues so as to determine the impacts of such issues on the Group's business operation, environment and society. Based on the Group's reporting scope and business characteristics as well as the feedback from stakeholders, the Group has identified the relevant material ESG issues and evaluated them through a scoring system. Details are shown in the chart below:

As shown above, the social and operational ESG issues are of high materiality to the Group based on the materiality assessment and the survey conducted with internal and external stakeholders by the Group. In particular, as the Group's business is principally engaged in the provision of entertainment services and property management business, the materiality of customer satisfaction is particularly emphasised to ensure that the services provided could satisfy the expectations of customers. In addition, the Group also emphasises issues such as corporate governance, service quality, economic performance, operational compliance and anti-corruption, so as to ensure the sustainable development of business with good corporate ethics and culture.

遵守環境保護相關的法律法規

In the future, the Group will be more proactive to maintain communication with stakeholders and collect advises from them through different channels to conduct more comprehensive analysis and continue to promote the Group's sustainable development plan. Meanwhile, the Group will conduct materiality assessment on ESG issues as necessary, so as to comply with reporting requirements and better satisfy expectations of stakeholders on the content and disclosure of ESG report.

如上所示,本集團經過對內部及外部持份者進 行的重要性評估調查,顯示社會及營運方面的 ESG議題對本集團的重要性較高。具體而言,由 於本集團的業務以提供娛樂服務及物業管理業 務為主,因此特別强調客戶滿意度的重要性,以 確保所提供的服務能滿足客戶之期望。此外,本 集團亦強調企業管治、服務質量、經濟效益、營 運合規以及反貪腐等議題,確保業務可以在良 好的企業道德和文化下持續發展。

往後,本集團將更積極的與各持份者保持溝通, 通過不同渠道收集各方意見以進行更全面的分 析,繼續推進本集團之可持續發展計劃。同時, 本集團將按需要進行對ESG議題之重要性評估, 以便滿足ESG報告要求及更好地符合各持份者 對報告內容和信息披露的期望。

A. ENVIRONMENTAL

For the Group, we understand that a healthy environment is the basis for economic development and social well-being. As a responsible organisation, the Group will pursue environmental protection, strictly comply with the existing laws and regulations related to environmental protection, properly handle and dispose of all materials to avoid adverse impacts on health or environment

During the financial year of 2022/2023, the Group did not identify any crucial incidents of non-compliance relating to environmental problems.

A1. Emissions

The Group is also committed to promoting environmental protection during its daily operations. All operating units of the Group have implemented eco-friendly measures to reduce carbon dioxide emissions during operations.

Air Pollution Emissions

In view of the Group's business focusing on entertainment services and property management services, our business activities do not involve any air pollution emission arising from the use of gas fuel or automobile fuel.

Greenhouse Gas Emissions

Greenhouse gas emissions are a leading cause of global warming, which leads to sharp climate changes and poses a tremendous threat to the global ecosystem. The Group understands although we have no direct greenhouse gas emission, we inevitably generate indirect greenhouse gas during energy and water resources utilisation. In view of this, the Group, as an organisation with corporate social responsibility, considers the reduction of greenhouse gas emissions as a focus in daily operations.

The greenhouse gas emissions of the Group mainly come from energy consumption for business activities in various cities, including energy use, electricity consumed for treatment of drinking water and sewage, as well as greenhouse gas emissions indirectly generated by the employees taking planes for business trips. In addition, we promote greening construction in each of the property projects under our management as the best remedy for the greenhouse gas emissions generated due to our business activities.

A. 環境

對本集團而言,我們明白一個健康的環境 是經濟發展及社會福祉的基礎,作為一所 負責任的機構,本集團會奉行環保,嚴格 遵守現行環境保護相關的法例及規管,妥 善處理及棄置所有物料,確保不會對健康 或環境造成不良影響。

於二零二二/二三年財政年度期間,本集 團並未有發現任何重大與環境問題有關 的違規行為。

A1. 排放物

本集團在日常營運的過程中亦致力 促進於環境保護,本集團各營運單 位皆有實施對生態環境友好的措施, 以降低營運時產生的碳排放。

空氣污染排放物

鑒於本集團的業務範疇以娛樂服務 及物業管理服務性質為主,我們在 業務活動上並不涉及使用氣體燃料 或汽車燃料所產生的空氣污染排放 物。

溫室氣體排放

溫室氣體排放是造成全球暖化的元 兇,引致氣候劇變及對全球生態 統構成巨大威脅。本集團明體排放 我們並沒有直接的溫室氣體排放免 但在能源及水資源使用背後難免 間接產生溫室氣體。有見及此,本 團作為一所具社會責任的機構 少溫公 一個關注的方向。

本集團的溫室氣體排放主要來自各城市業務活動上的能源消耗,包括能源使用、處理食水及污水所消耗的電力及僱員乘坐飛機外出公幹時間接造成的溫室氣體排放等。我們於所管理的各物業項目內推行綠化建設,以盡量彌補業務活動過程中所產生並排放的溫室氣體。

The lifestyle entertainment segment in Hong Kong holds valid sewage treatment licenses, and its sewage discharge has been complying with the discharge limits specified in the licenses. As for the property projects under our management in Mainland China, sewage discharge mainly comes from the daily water consumption of property owners. We discharge wastes in a way stipulated by the municipal government, and maintain the pipelines, valves and other equipment related to the sewage discharge and exhaust systems on a regular basis to guarantee its normal operation.

According to the Reporting Guidance on Environmental KPIs issued by the HKEx, greenhouse gas emissions can be categorized into the following three main scopes:

- Scope 1: Covers greenhouse gas emissions directly generated by businesses owned or controlled by the Company, such as greenhouse gas emissions from fuel combustion of stationary sources and mobile sources;
- Scope 2: Covers the energy indirect emissions of greenhouse gas from electricity, heat, cooling and steam consumed within the Company, such as greenhouse gas emissions in relation to purchased electricity and/or town gas;
- Scope 3: Covers all other indirect greenhouse gas emissions, including emissions from both upstream and downstream activities, that occur outside the company, such as methane generated during the process of waste paper being delivered to landfills, electricity consumed by water supply authority for processing fresh water and sewage, etc.

The total greenhouse gas emissions generated by the Group in the Financial Year 2021/2022 were approximately 50,049.2 tonnes (Financial Year 2021/2022: 71,103.8 tonnes), the greenhouse gas emissions decreased by approximately 29.6% as compared to the 2021/22 Financial Year (from 1 April 2021 to 31 March 2022). The decrease in emissions was mainly attributable to the reduction in electricity consumption from construction activities and garage lightings by the property management segment, as well as the use of energy-efficient lighting installations in public areas.

本集團香港生活娛樂分部持有有有有的污水處理牌照,污水排放放量限所可的遵守牌照內所可的地所管理限內所可則所有有亦制,污水排放主要不可自力。業日常生活之用水量。我們已期沒數的市式排放,並定門及所以,排氣系統的管道、內理,以確保其運作正常。

按香港交易所發佈的《環境關鍵績效指標彙報指引》,溫室氣體的排放主要可分為下列三大範圍:

- 範圍一:涵蓋由公司擁有或控制的業務直接產生的溫室氣體排放,例如由固定源或流動源燃燒燃料所釋放的溫室氣體;
- 範圍二:涵蓋來自公司內部消耗電力、熱能、冷凍及蒸汽所引致的"能源間接"溫室氣體排放,例如外購電力及/或煤氣相關的溫室氣體排放;
- 範圍三:涵蓋公司意外發生的 所有其他間接溫室氣體排放, 包括上游及下游的排放,例如 廢紙用送至堆填區所產生的甲 烷、水務機構處理淡水及污水 所耗的電力等。

本集團於二零二二/二三財政年度 所產生的溫室氣體排放總量約為 50,049.2噸(二零二一/二二財政 年度:71,103.8噸),較二零二一/ 二二財政年度(即二零二一年四月 一日至二零二二年三月三十一日) 之溫室氣體排放量下降約29.6%,排 放量下降主要是由物業管理分部減 少工程用電及車庫照明、公共區域 夜間照明改用節能燈泡。

In the 2022/23 Financial Year, the Group did not directly generate greenhouse gas emissions (scope 1) due to business needs. Approximately 96.9% of the greenhouse gas emissions were indirect emissions (scope 2) generated by electricity consumption. The remaining 3.1% of greenhouse gases were of other indirect emissions. For more details, please refer to the table below:

As its difficult to obtain relevant figures in PRC, the above figures are set to be consistent with that in PRC. Due to limitations in data collection, the per unit electricity consumption for processing water and sewage in Mainland China will refer to the latest figures published by the Hong Kong Water Supplies Department and Drainage Services Department.

The main greenhouse gas emissions of the Group come from the operating activities of the property management segment. The greenhouse gas emissions in Financial Year 2022/23 reached approximately 49,872.2 tonnes (Financial Year 2021/22: 70,918.9 tonnes), amounted to approximately 99.6% of the Group's total greenhouse gas emissions, while the greenhouse gas emissions from lifestyle entertainment segment in Financial Year 2022/23 were approximately 177.0 tonnes (Financial Year 2021/22: 184.9 tonnes), amounted to approximately 0.4% of the Group's total greenhouse gas emissions.

For the greenhouse gas emission density, the greenhouse gas emission density of the property management segment was approximately 906.8 tonnes/property project in Financial Year 2022/23 (Financial Year 2021/22: 1,325.6 tonnes/property project), representing a decrease of approximately 31.6% as compared to that of Financial Year 2021/22. The greenhouse gas emission density of the lifestyle entertainment segment was approximately 50.6 tonnes/business premises.

本集團主要的溫室氣體排放來源於物業管理分部之經營活動,於二點 二二/二三財政年度之溫室零二一/ 二二財政年度:70,918.9噸),約佔本集團溫室氣體總排放量之99.6%,而生活娛樂分部於二零二二/二月 財政年度之溫室氣體排放量之99.6%,177.0噸(二零二一/二二財政年度:184.9噸),約佔本集團溫室氣體總排放量之0.4%。

溫室氣體排放密度方面,於二零二二/二三財政年度,物業管理分部之溫室氣體排放密度約為906.8噸/個物業項目(二零二一/二二財政年度:1,325.6噸/個物業項目),較二零二一/二二財政年度下降約31.6%;生活娛樂分部之溫室氣體排放密度約為50.6噸/個經營場所。

Although the energy consumption in relation to the property management segment is mainly caused by the owners, that is not within the control of staff of the property management segment. The property management segment promotes the conservation of electricity and water in the area of property projects, and promotes environmental protection measures to property owners, in order to minimize the impact of business on the environment. In addition, the Group implements various solutions in the sustainable energy efficiency plan to reduce the generation of greenhouse gases, including but not limited to the implementation of greening within the area of property projects, posting signs to remind employees of saving electricity and water, and the use of energy-saving LED lights in property projects.

Looking ahead, given that energy use is the main source of the Group's greenhouse gas emissions, the Group will continue to strengthen energy conservation monitoring measures, ensuring that all electrical appliances are properly turned off when not in use and that all lights and air conditioners are turned off outside office hours, to avoid unnecessary consumption of electricity.

Target for Greenhouse Gas Emissions

As the Group's GHG emissions are directly related to its business operations of entertainment services and property management services, most of the GHG emissions are mainly generated by users of the residential estates under the management of the property management segment, which are not controllable by the Group directly. Nevertheless, the Group will continue to strengthen the implementation of energy conservation monitoring measures and minimise unnecessary resources consumption during the operation of the lifestyle entertainment segment by the Group, and still be devoted to the promotion of resources conserving when providing the property management service by property management segment, so as to minimise the indirect greenhouse gas emissions arising from the operation of the Group by continuously taking practical measures.

展望未來,由於能源使用為本集團溫室氣體排放之主要源頭,本集團將繼續加強節能監控措施,以確保所有閒置電器有妥善關上,並確保於辦公時間結束後,關上所有電燈及空調,以減少不必要用電。

溫室氣體排放目標

Wastes Management

In Financial Year 2022/23, no hazardous waste was found in the operations of lifestyle entertainment segment and property management segment.

Despite the constraint to calculate the amount of non-hazardous waste generated in the operation of the lifestyle entertainment segment of the Group due to data collection limitation, the Group is committed to reducing waste generation to an extent controllable and encouraging employees to classify and recycle waste. The Group hopes to promote waste reduction at the source, starting from reducing the use and packaging to decrease waste generation. In addition, for the waste cooking oils of the restaurants, the Group engages qualified waste collectors to collect waste cooking oils generated from their operating activities for recycling on a regular basis.

The property management segment has entrusted the local qualified wastes transportation agency to transport and dispose of the non-hazardous wastes produced by the property owners, and enabled the recycling of wastes. All wastes have been disposed of in compliance with local laws and regulations. Recycled materials concentration points have been set in the service areas to carry out collection, classified management and declaration of the statutory hazardous wastes and recyclable wastes.

As for the domestic garbage discarded every day by users in the residential areas, the property management segment has set up waste recycling bins to collect recyclable wastes, and arranges special staff to classify and store the recycled wastes separately every day, and deliver the recycled wastes regularly to the waste transfer station or the solid waste recycling treatment plant.

However, as it is difficult to collect data about the intensity and quantity of wastes, and the weight is estimated on a monthly basis, the Group failed to report the weight of relevant wastes. Although relevant wastes of the property management segment are mainly generated by the property owners, which is beyond the controllable range of the property management segment, the property management segment will still strengthen the waste classification, recovery and disposal process, and attempt to reduce the impact of its business on the environment.

廢棄物管理

於二零二二/二三年財政年度,生活娛樂分部及物業管理分部之營運 過程中均不涉及有害廢棄物的產生。

物業管理分部已委託當地合格清運商對物業住戶所產生的無害的棄生戶所產生的無害能避實使用,而所有廢棄物均已害性廢理。法定危害性廢與可資源化廢棄物,則於服棄區、內與置回收物料集中點進行收集、分類管理及申報作業。

針對住宅區內用戶每天棄置的生活 垃圾,物業管理分部已設置廢物回 收箱,用以收集可循環再利用的廢 物,並安排專人每天對回收廢物加 以分類存放,定期把回收的廢物送 往垃圾轉運站或固廢循環利用處理 廠。

Waste Management Goals

Although the amount of non-hazardous waste generated by the Group is directly related to its business operations, where the amount of non-hazardous waste generated by the owners who are not under the direct control of the Group, the Group will still be devoted to the promotion of waste reducing at source within the residential estates under its management, and strengthen the waste management process in its business operations so as to minimise the impact of the Group's business operations on the environment.

A2. Use of Resources

The Group undertakes to become a resource-saving and environment-friendly enterprise and makes our contributions to environmental protection. To reduce carbon emissions, we've taken the initiative to perform the energy-saving measures in our business activities.

Energy consumption

The Group's energy consumption is mainly derived from indirect energy consumption in relation to purchased electricity. In Financial Year 2022/23, the total electricity consumption of the Group was approximately 84,976.2 MWh (Financial Year 2021/22: approximately 98,320.1 MWh), representing a decrease of approximately 13.6% as compared to that in Financial Year 2021/22, which is mainly attributable to the reduction in electricity consumption by the property management segment. The electricity consumption of each segment of the Group is as follows:

本集團的能源消耗主要源自於外購電力形式的間接能源消耗。於二零二二/二三財政年度,本集團總能消耗約84,976.2兆瓦時(二零二一/二二財政年度:約98,320.1兆瓦時),較二零二一/二二財政年度下降約13.6%,主要是由於物業管理分部減少用電。本集團各分部之電能消耗情況如下:

For the energy use density, electricity consumption density of the property management segment in Financial Year 2022/23 was approximately 1,539.9 MWh/property project (Financial Year 2021/22: approximately 1,832.4 MWh/property project), representing a decrease of approximately 16.0% as compared to that in Financial Year 2021/22.

The energy consumption density of the lifestyle entertainment segment in Financial Year 2022/23 was approximately 81.1 MWh/business premises (Financial Year 2021/22: approximately 71.1 MWh/business premises), representing an increase of approximately 14.1% as compared to that in Financial Year 2021/22.

The management of the Group remains committed to enhancing environmental awareness of our employees and placing more electricity saving labels, to further encourage employees to reduce unnecessary electricity consumption, minimize energy use and reduce the impact of business operations on the environment.

Energy Use Goals

Nevertheless the Group's electricity consumption is directly related to its business operations, and the electricity consumption from residents is not within the Group's direct control, the Group will still be devoted to the promotion of electricity saving within the residential estates, strengthen the management of electricity use in the lifestyle entertainment and property management segment, and successively purchase electrical appliances when necessary to maximise energy efficiency and avoid unnecessary waste of electricity, so as to reduce the impact on the environment through continuous monitoring, implementation and optimisation of existing measures.

Water Resource Consumption

As potable water is a precious resource on the Earth, saving water is one of the goals of the Group. The Group also makes efforts to reduce electricity consumption generated from water supply, thereby reducing the Group's carbon footprints and resource consumption. As the water source of the Group's lifestyle entertainment segment and property management segment is supplied by the government's water supply department, so there is no problem in obtaining water source.

至於能源使用密度方面,物業管理分部於二零二二/二三財政年度的電能消耗密度約為1,539.9兆瓦時/個物業項目(二零二一/二二財政年度:約1,832.4兆瓦時/個物業項目),較二零二一/二二財政年度下降約16.0%。

生活娛樂分部於二零二二/二三 財政年度的電能消耗密度約為81.1 兆瓦時/個經營場所(二零二一/ 二二財政年度:約71.1兆瓦時/個經 營場所),較二零二一/二二財政年 度上升約14.1%。

本集團管理層將繼續致力提高集團 內員工的環保意識,及增加節約用 電的提示標籤,以進一步鼓勵員工 減小不必要的用電,盡可能降低能 源使用及減低業務營運對環境帶來 的影響。

能源使用效益目標

水資源消耗

食水是地球上非常珍貴的資源,珍惜用水是本集團的目標之一,務求達至減低供水時所產生的電力消耗,從而降低本集團之碳足印及資源消耗。本集團生活娛樂分部及物業管理分部之水源來自政府供水部門,因此未有出現求取水源上之任何問題。

The water consumption of the Group in Financial Year 2022/23 was approximately 2,474,154.5 tonnes (Financial Year 2021/22: 2,055,587.3 tonnes), representing an increase of approximately 20.4% as compared to that in Financial Year 2021/22, which is mainly attributable to that, the owners of various projects strengthened the cleanliness in postpandemic era, resulting in an increase in water demand. The water resource consumption of each segment of the Group is as follows:

The context of water consumption is similar to that of the electricity consumption in the property management segment, which is mainly refer to the consumption of property owners. Although the property management segment cannot directly reduce the consumption of water resources, it will still actively promote water conservation in property projects under its management and encourage the recycling of water resources, such as use of recycled water for sanitation and cleaning, and use of appliances with higher water efficiency, etc.

Water Efficiency Goals

Although the water consumption of property owners is beyond direct control of the Group, the Group is still committed to promoting the concept of water conservation to property owners and enhancing water management in offices, lifestyle entertainment and property management segment to maximise the water efficiency and avoid unnecessary wastage, so as to reduce the impact on the environment through continuous implementation and optimisation of the existing measures mentioned above.

物業管理分部的耗水量與電能消耗相似,主要為業主用量所致。雖然物業管理分部不能直接減少有關於物資源的消耗,但仍會積極於物業管理項目內推廣節約用水,鼓勵循環用水資源,例如可以使用循環用水進行衛生打掃,以及使用用水效能較高的電器家品等。

用水效益目標

雖然來自業主的用水量並非本集團能直接控制之範圍,但本集團仍然致力向業主宣傳節約用水的理念,並加強辦公室、生活娛樂分部及物業管理分部之用水管理,以盡量提高用水效率及避免造成不必要的現費,透過持續實施及優化上述的現有措施減低對環境造成的影響。

Packaging Materials

In view of the Group's business focusing on restaurant and club, and property management services, our business activities do not involve any packaging materials used for finished products.

Energy Use Efficiency Initiatives

Currently, the Group mainly uses the energy of electric energy and water resources. In the face of the increasingly severe environmental pollution, the Group, as a part of the community, is committed to implementing energy saving measures in different levels of routine operations, including:

A3. The Environment and Natural Resources

The resources and energy consumed by the Group's main business activities are mainly water and electricity, and the pollution caused by business activities to the environment is mainly the greenhouse gas emissions. The management of the Group is responsible for overseeing the daily operations by reminding all employees of implementing the Group's energy-saving and emission-reduction measures, criticizing and rectifying the waste of resources, and avoiding unnecessary resource consumption, in order to minimise the adverse impact on the environment.

The property management segment of the Group delicately develops gardens and greening space for each project by virtue of professional greening management, such as planting diverse flowers, grasses and trees, which improves the microclimate in the community, enriches the landscaping in the community, and enables the property owners to experience the biodiversity of the nature. One of the residential estates managed by us has been honoured as the "most beautiful courtyard" by the government.

A4. CLIMATE CHANGE

The Group understands that climate change may bring different levels of impact and risks to its business. As greenhouse gases such as carbon dioxide and methane generated by the development of human activities accelerate the greenhouse effect, the impact of climate change is becoming more obvious.

In view of the trend of sustainable development and transition to a low-carbon economy, as well as the uncertainties associated with physical and transitional risks arising from climate change, the Group recognises the importance of incorporating climate factors into the decision-making process to formulate an effective plan to address climate change. Therefore, the Group has started to study the potential impact of climate change, so that the Group will be able to identify, assess and manage various risks in a timely manner in the future and prepare for the planning strategy of addressing climate change.

In terms of physical risks, rising temperatures will have short-term and long-term impacts on climate patterns and seasonal weather, and increase the possibility of extreme weather events, such as more frequent occurrence of severe weather events, including heavy rains, typhoons, high temperatures and floods. These extreme weather events are likely to affect the Group's business operations, causing events such as natural disasters that prevent its business from normal operation and lead to mandatory downtime, damage to equipment, supply chain disruptions that affect the provision of services to customers and other events that increase operating costs. In addition, severe weather also poses threats to the safety of employees. In this regard, the Group has formulated guidelines on severe weather arrangements to reduce the risk of injury and accidents. In addition, the property management segment has also made arrangements for its property management business in respect of severe weather work, disaster prevention and emergency response plans, and enhanced its emergency response capabilities in disaster prevention and mitigation under special weather conditions through enhanced drills and regular safety inspections.

A4. 氣候變化

本集團了解氣候變化將對其業務帶來不同程度的影響和風險。隨著人類活動發展產生的二氧化碳和甲烷等溫室氣體加速溫室效應,氣候變化帶來的影響亦越趨明顯。

就實體風險而言,持續上升的氣溫 會為氣候模式及季節性天氣帶來短 期和長期的影響,並增加發生極端 天氣情況之可能,例如將更頻密發 生暴雨、颱風、高溫及洪水等惡劣天 氣事件情況等。這些極端天氣事件 很大可能影響本集團的業務營運, 包括因自然災害而阻礙其業務無法 如常運營及導致強制停工之情況、 設備損毀、供應鏈中斷而影響為向 客戶提供服務等事件增加營運成本。 此外,惡劣天氣亦對員工的安危帶 來威脅。對此,本集團已編制有關惡 劣天氣上班安排的指引,以減低員 工因惡劣天氣受傷及發生意外的風 險。另外,物業管理分部亦有為其物 業管理業務制定有關惡劣天氣的工 作、防災及應急預案之相關安排,透 過加強演練及恆常的安全檢查以提 高於特殊天氣情況下防災避險的應 急能力。

In addition, with the attention of many countries on climate change, it is expected that more climate conferences and climate policy-related arrangements will be arranged in the future, which may lead to higher operating costs and different market risks for the Group. In terms of China's goal of achieving carbon neutrality by 2060, there is expected to be a gradual tightening of regulations on emissions. As a result, the Group may face additional operating costs as a result of a cost shift from its service providers such as power companies, water providers and waste treatment and recycling companies. In this regard, the Group will keep abreast of changes in market information and energy policies to ensure the timeliness of the information while facilitating the formulation of relevant corresponding policies to mitigate the risks.

The Group will continue to adopt best practices to minimise its own carbon footprint and incorporate resilience into its business operations so as to effectively control the impact of climate change on the Group.

B. SOCIAL

The Group is aware that our business success depends on the cooperation and cohesion of our teams. Our teams are the most precious assets of the Group. Therefore, based on the people-oriented core values, we are committed to providing attractive remunerations, benefits and welfares for employees, arrange reasonable working hours and holidays, and ensure all employees enjoy equal opportunity. The Group also holds internal activities on a regular basis and encourage the employees' participation to increase the Group's cohesion, strengthen the employees' recognition of the Group, and reinforce their sense of belonging.

During Financial Year 2022/23, the Group did not find any breach of laws and regulations on employment, health and safety, labour standards, product liability and anti-corruption.

B1. Employment

Our Employees

As of 31 March 2023, the Group has recruited 994(31 March 2022: 1,089) employees in total, including 955(31 March 2022: 1,046) employees of property management segment and 39 (31 March 2022: 43) employees of lifestyle entertainment segment.

Among all employees of the Group, as of 31 March 2023, approximately 71% of the total number of employees (31 March 2022: 69%) were male, while approximately 29% of the total number of employees (31 March 2022: 31%) were female. As of 31 March 2023, the Group had 989 full-time employees and 5 part-time employees. Approximately 95% of the Group's employees were from China, about 4% were from Hong Kong and about 1% were from other regions (such as Nepal, etc). 



Number of Employees by Gender 按性別劃分之員工人數




Number of Employees by Age 按年齡組別劃分之員工人數

Employee Benefits and Assessment

The Group deeply acknowledges that the Group's development and success indeed rely on the efforts of all employees, so the Group provides competitive salaries to pay back the employees' efforts. In addition to providing attractive remunerations and benefits to employees, the Group not only offers performance bonuses according to the Group's business results and the employees' performance, but also distributes holiday benefits on traditional festivals every year. The Group also provides Mandatory Provident Fund Schemes ("MPF") for employees in accordance with the Employment Ordinance of Hong Kong, and pays endowment insurance, medical insurance, unemployment insurance, work-related injury insurance, maternity insurance and housing provident fund for employees in accordance with the Labour Law of the People's Republic of China.

員工福利及考核

In order to reward hard-working employees more effectively, the Group has established a well-organised performance management system to efficiently motivate their sustainable development, help employees make planning for their career, realise talent inheritance, and enable the Group to develop toward the sustainable operation goal. The Group implements monthly, quarterly and yearly performance assessment to help employees establish definite, measurable, achievable, position-related and time-sensitive key performance indicators of their own, supervise their progress on a regular basis, and take appropriate improvement measures if applicable. The Group will adjust the remuneration of employees regularly by referring to their assessment results and comprehensive evaluation and by combining the Group's overall business performance, so as to ensure employees gain the best remunerations in proportion to their efforts.

A Harmonious Working Environment

The Group is devoted to creating a harmonious and embracing working environment for employees, and to protecting them from any harassment or discrimination. The Group treats its employees fairly and equally regardless of their gender, sexual orientation, disability, age, nationality or ethnic origin, family status or other personal characteristics that are protected by law. As for our systems for recruitment, remunerations and benefits, holidays, trainings, assessment, promotion, etc., we evaluate the employees according to their abilities, skills, qualifications and performances.

Work and Life Balance

In order to ensure our employees achieve balance between work and life, and maintain a balanced and healthy lifestyle, our actual working time is eight to ten hours a day and five to six days a week, so that our employees can have sufficient time to rest. The Group provides employees with relevant paid leaves in accordance with local laws and regulations. The employees of the property management segment can enjoy annual leave of five to fifteen days as well as other statutory labour holidays according to their position level. In addition, employees also enjoy compassionate leave, marital leave, maternity leave, etc. As for the property management segment, an employee with a new-born baby under one year of age can further enjoy thirty-minute breastfeeding leave twice a day.

Moreover, the property management segment provides a series of facilities for employees, including dining hall and dormitory, so as to improve their sense of belonging to the Group, help those employees who come to work far away from home to achieve work-life balance more easily, and alleviate their economic burdens. In addition, the property management segment also arranges after-work activities and dinners for employees to promote communication among employees from different departments and enhance cohesion among employees through enhanced communication.

Communication Channels for Employees

The Group attaches importance to the opinions of employees. All employees and the management are encouraged to use our diversified communication channels, such as: e-mail, forum or bulletin board, to realise horizontal or vertical communications. Generally when an employee has any complaint against his/her work, we will arrange the department supervisor to have an interview with him/her, while the employee can also complain against the person or department concerned. If the person or department being complained against fails to provide satisfactory solutions, the complaint will be submitted to the superior department level by level, so as to ensure the employees can receive a clear feedback.

The Company encourages employees to raise reasonable suggestions about the Group. The HR Department is responsible for collecting suggestions of employees and guaranteeing their accurate delivery.

Talent Retention

The Group cherishes talents, and the above-mentioned HR management measures have successfully managed the monthly average turnover rate of the Group to approximately 4.3% in Financial Year 2022/23 (Financial Year 2021/22: 4.7%). The monthly average turnover rate by gender is 4.0% (male) and 4.9% (female). The monthly average turnover rate by age group is 6.6% (18 to 25), 6.3% (26 to 35), 3.6% (36 to 45), 2.6% (46 to 55) and 2.6% (56 to 65). Monthly average turnover rate by region was 4.3% (China) and 4.4% (Hong Kong).

員工溝通渠道

人才挽留

本集團愛惜人才,以上的人力資源管理措施,於二零二二/二三財政年度,成功為本集團將月平均人員流失比率控制在約4.3%(二零二一/二二財政年度:4.7%)。按員工性別劃分的每月平均流失率為4.0%(男性)及4.9%(女性)。按員工年齡組別劃分的每月平均流失率為6.6%(18至25歲)、6.3%(26至35歲)、3.6%(36至45歲)、2.6%(46至55歲)及2.6%(56至65歲)。按地區劃分的每月平均流失率為4.3%(中國)及4.4%(香港)。

B2. Health and Safety

Health and safety of the employees are of vital importance to the Group. The Group is committed to providing a safe working environment for employees, and guarantees to fully comply with all occupational health and safety regulations. All offices and office premises of the Group are equipped with adequate safety equipment, such as fire-fighting equipment, to prevent fires and ensure a safe working environment. The Group has enhanced information and rules about occupational health and workplace safety in the employee handbook, and has formulated policies about the safe working environment, such as Special Measures against Typhoon and Rainstorm, defining working procedures and evacuation issues in severe weather. Apart from this, the Group will invite fire protection equipment suppliers to give lectures about fire safety awareness on a regular basis and provide fire drills for employees to ensure that they are familiar with the necessary procedures if a fire breaks out.

Any employee suffering from work-related injuries is entitled to corresponding compensation benefits in accordance with relevant national regulations. In the case of Hong Kong employees, the Group will report the case to the Labour Department in accordance with section 15 of the Employees' Compensation Ordinance, and contact the insurance company for settlement of claims. In the meantime, the Group will also provide sufficient work-related injury leave to allow the employee sufficient rest.

In the Financial Year, the Group recorded 5 cases of work-related injury, all of which were in relation to the property management segment. The number of working days lost due to work-related injuries was approximately 195 days. In Financial Year 2021/22, the Group had a total of 5 cases of work-related injuries, and the number of working days lost due to work-related injuries was approximately 563 days. No relevant figures have been disclosed for the Financial Year 2020/21 (from 1 April 2020 to 31 March 2021).

B2. 健康與安全

員工的健康與安全對本集團至關重 要,本集團致力為員工提供一個安 全的工作環境, 並確保完全遵守所 有職業健康和安全相關規定。本集 團各個辦公室及辦公場所均有配備 充足的安全装備,如消防設備,以防 火災發生並確保工作環境的安全。 本集團已於《員工手冊》內加入有 關職業健康及工作間安全的資訊及 守則,並制定了有關安全工作環境 的政策,如《颱風及暴雨特別措施》 釐定惡劣天氣下的工作程序與疏散 事項。此外,本集團會與防火設備供 應 商 定 期 進 行 火 警 安 全 意 識 講 座, 及對員工進行火警演習,以確保所 有員工熟悉火災警報時的程序。

如任何員工因工受傷,均可按照國家相關規定享受補償福利。就香港員工的個案而言,本集團會依從《僱員補償條例(經修訂)》第15條,按規定將有關個案通報到勞工處,並聯絡保險公司進行理賠。同時,本集團亦會提供足夠的工傷假期予員工得到充分的休息。

於本財政年度,本集團共發生5宗員 工工傷受傷個案,均來自物業管理 分部,因工傷損失的工作日數約 195天;於二零二一/二二財政年 度,本集團共發生5宗工傷個案,因 工傷損失的工作日數約為563天;於 二零二零/二一財政年度(即由二 零二零年四月一日至二零二一年三 月三十一日期間)未有披露相關數據。

In this Financial Year, the Group had 1 case of work-related fatality. One of the employees of the property management segment met a traffic accident on the way to work, resulting in serious injury and even death. We are deeply sorry for the sadness. We expressed our sympathy to the family of the victim immediately after the accident occurred. We also sent dedicated staff to arrange follow-up actions with the family members of the victim and relevant governmental departments, in order to provide necessary assistance to the family of the victim as soon as possible. Learning from the past, the management enhanced publicity to promote traffic safety to all employees and publicized the importance of traffic safety, so as to avoid similar incidents from happening again in the future.

B3. Development and Training

The Group encourages employees to participate in all kinds of in-service training, and also provides employees with various internal and external training and development opportunities to help them maximise their business potential.

The annual assessment results will be used to provide suitable trainings for employees, in an effort to continuously improve the Group's talent quality and working skills, motivate working enthusiasm of employees and stimulate them to face challenges. Apart from considering the Group's business vision and target needs, the training and development programme also simultaneously evaluates employee performance and functional gap, coordinates with the Company and the management in establishing the education and training framework, and makes plans for internal and external courses such as new employee training, professional training, training of various management levels, training relating to environmental protection, core values of the Group, etc. through physical or electronic learning methods, providing employees with allround training, and enables the Group's employees to continue improving their professional and managerial competence, find out the platforms where they can show their abilities, grow together with the Group, and establish a steady cooperative relationship.

B3. 發展及培訓

本集團鼓勵員工參加各種在職培訓, 也為員工提供各類內部及外部的培 訓與發展機會,以幫助員工發揮最 大的業務潛能。

員工的年度考核結果均會用以為員 工提供合適的培訓,以不斷提升本 集團人力素質與工作技能,並激發 員工工作熱忱並迎接挑戰。訓練發 展規劃除了考慮本集團經營願景及 目標需求外,亦同步評估員工績效 與職能缺口,配合公司與管理體系 建立教育訓練架構,規劃新人訓練、 專業訓練、各階層管理訓練、環境保 護的相關訓練及本集團核心價值等 內外部課程,透過實體或電子化學 習的方式,提供員工全方位的培訓, 讓本集團員工能不斷提升其專業與 管理能力,找到自己發揮之舞臺,與 本集團共同成長並建立穩定之合作 關係。

The Group arranges new employees to receive on-boarding training, aiming to make the employees know about the Group, master the codes of practice, techniques and methods for handling business, and adapt to the new environment and new job quickly. In addition, the Group also provides training on safety knowledge and environmental protection knowledge for employees, which helps establish their awareness of safety and environmental protection. Apart from the training on technical procedures, employees can also participate on fire training so as to enhance their awareness of fire prevention.

In this Financial Year, the percentage of employees trained in the property management segment is 32% (Financial Year 2020/22:71%). In Financial Year 2021/22, the property management segment has provided a total of approximately 5,194 hours (Financial Year 2020/22: 2,994 hours) of trainings for employees, with an average of approximately 4.9 hours (Financial Year 2020/22: 3.4 hours) of training received by each trained employee. The percentage of employees trained by gender is 62% male and 38% female, while the percentage of employees trained by employee category is 42% (general staff), 41% (middle management) and 17% (senior management). On the other hand, the average training hours per employee by gender were approximately 1.0 hours (male) and 3.0 hours (female) respectively, and by employee category were approximately 0.3 hours (general staff), 8.6 hours (middle management) and 2.5 hours (senior management).

The percentage of employees trained in the lifestyle entertainment segment is 28% (Financial Year 2020/22:33%). In Financial Year 2021/22, the lifestyle entertainment segment has provided a total of approximately 36 hours (Financial Year 2020/22: 24 hours) of trainings for employees, with an average of approximately 3 hours (Financial Year 2020/22: 3 hours) of training received by each trained employee. The percentage of employees trained by gender is 92% male and 8% female, the average training hours for both male and female were 1.0 hour and 0.3 hour respectively, and all trained employees were general staff.

於本財政年度,物業管理分部已接 受培訓僱員的百分比約為32%(二 零二一/二二財政年度:約71%)。 物業管理分部於二零二二/二三財 政年度,已提供共約5,194小時(二 零二一/二二:2.994小時)的培訓 予員工,平均每位受訓員工共接受 約4.9小時(二零二一/二二:3.4小 時)的培訓。受訓僱員當中按性別 劃分的比率分別為62%男性和38% 女性,而受訓僱員按僱員類別劃分 的比率分為42%(普通員工)、41% (中層管理人員)及17%(高級管理 人員)。另一方面,每名僱員平均受 訓時間按性別劃分分別約為1.0小時 (男性)及3.0小時(女性),按僱員類 別劃分則約為0.3小時(普通員工)、 8.6小時(中層管理人員)及2.5小時 (高級管理人員)。

而生活娛樂分部於本財政年度,已接受培訓僱員的百分比為28%(二零二一/二二財政年度:33%)。 等二一/二二財政年度:33%)。 等二一/二二財政年度:33%)。 年度,已提供共約36小時(二零二票 /二一:24小時)的培訓予員工, 均每位受訓員工共接受約3小時(等二零/二一:3小時)的培訓。 別劃分的比率分別計 92%男性和8%女性,男女平均受到 時數分別為1.0小時及0.3小時,而全 部受訓僱員均為普通員工。

In the future, the Group will continue to provide adequate training for its employees, so as to enhance their knowledge and skills while contributing to the sustainable development and progress of the Group.

B4. Labour Standards

The Group has established an employment and welfare policy in compliance with the Employment Ordinance of Hong Kong and the labour laws of the PRC, and strictly prohibited the recruitment of any candidate under the age of 18 to avoid the recruitment of any child labour and forced labour. The Group will never recruit any child labour under the age restricted by local laws, and the Group's HR Department will require the job candidates to provide valid identification certificates to confirm their actual age at time of interview. Once any misuse of child labour is found, the Group will immediately suspend his/her work, send the child labour back to his/her original residence, and deliver to his/her parent or legal guardian, for which the Group will bear the required transportation and accommodation expenses, and pay the salary due for his/her actual work.

The Group has not experienced any labour disputes or cases of forced labour during the fiscal year. The Group undertakes to maintain strict compliance with the Standard of regulations at any time. Any employee facing or discovering violations can report to the management through the reporting mechanism, and the management will take it seriously and take appropriate actions to follow up.

往後,本集團將繼續為員工提供充足的培訓,務求為提升員工自身學識和技能的同時,亦助力集團持續發展及進步。

B4. 勞工準則

本集團於本財政年度並未有發生任何勞資糾紛,亦未有出現任何強制勞工之情況。本集團承諾今後均會保持嚴守法規之標準,如有任何與員工面對或發現違規行為,皆可通過舉報機制向管理層通報,管理層將嚴肅對待事件並採取適當跟進行動。

B5. Supply Chain Management

The Group attaches great importance to procurement principles. In the procurement of materials and services, the Group has established procurement policies and procedures to promote fair and open competition. We ensure that we are able to meet the best economic benefits in terms of price, quality, delivery period and service when purchasing materials and hiring services. As a responsible organisation, the Group abides by the spirit of contract and complies with the principles, objectives and contents of the contract signed between us and the suppliers. During the Financial Year, the Group cooperated with a total of 346 suppliers, of which 33 suppliers were located in Hong Kong and the remaining 313 suppliers were located in the PRC.

The Group has the responsibility to ensure that procurement of materials and services is conducted in a highly professional manner and complies with the established code of ethics, so that the resources are used properly, and the suppliers will have the confidence in continuing doing business with the Group. We must ensure that the suppliers understand and comply with the Code of Conduct and the procurement policies formulated by the Group. The Group has established a list of selected suppliers. Before any supplier is approved to enter this list, we will review their company backgrounds (including the recognitions, qualifications and licenses they have obtained), product pricing and supply terms. In order to standardise relevant systems and processes, the Group has formulated relevant work guidelines and standardised contract forms, and conduct year evaluation on the products and services of suppliers on a regular basis to guarantee their compliance with the Group's strict standards.

The list of selected suppliers will be reviewed at the end of each year. Such review involves the evaluation on whether a supplier's pricing, product and service quality, efficiency, reliability, the ability to deliver goods on schedule, licence update and technical capability are still in compliance with the Group's requirements and standards.

B5. 供應鏈管理

本集團有責任確保物料和服務的採 購以高度專業方式進行,並符合所 定的道德準則,以確保資源用得其 所,並讓供應商有信心與本集團持 續往來業務。我們必須確保供應商 明白及遵從本集團所訂立的行為守 則及採購政策。本集團已設立一份 選定供應商名單,在供應商獲批准 納入名單前,我們會審閱其公司背 景(包括彼等已取得的認可、資格及 許可證)、產品定價以及供應條款。 為規範相關制度及流程,本集團擬 定了相關的工作指引及標準化合同 文本,並定期對供應商的產品及服 務等表現進行年度評估,以確保彼 等符合本集團的嚴格標準。

選定供應商名單會於每年年底予以審閱。該審閱涉及有關彼等在定價、產品與服務質量、效能、可靠性、準時交付貨物的能力、許可證更新、技術能力方面是否仍然符合本集團要求及標準的評估。

The Group selects reputable and reliable suppliers to provide high-quality, affordable and sustainable products and services. The Group has a transparent and independent procurement process, with an aim to promote competitiveness. This move will also serve the benefit of our shareholders and other stakeholders. The Group expects to establish a vertically integrated supply chain management system by integrating the procurement resources and developing the supplier selection and management mechanism, thereby actively providing comprehensive solutions and satisfying customer needs. The Group expects to review the quality and performance of suppliers by conducting relevant assessments and reviews, and to ensure communication between the procurement process so as to accurately convey the Group's expectations to suppliers. Although the Group's main business does not involve environmentally friendly products and services when selecting suppliers, it still expects that suppliers can comply with relevant environmental standards and regulations, and save resources as much as possible to contribute to environmental protection.

Meanwhile, the Group encourages suppliers to promote corporate social responsibility activities and abide by corporate social responsibility rules and environmental regulations. All business transactions shall maintain high-standard ethics; bribery or other illegitimate benefits must not be provided or accepted; information relating to business activities, structure, financial status and performance shall be disclosed on a regular basis in accordance with applicable laws and regulations.

B6. Product Liability

In order to maintain the Group's position in its clubbing and entertainment business and property management business and sustainability, the Group strictly complies with the quality standards of the industry to protect the Group's reputation and public interests. The Group has strictly complied with the laws and regulations relating to health and safety, advertising, labelling and privacy matters of its products and services. No non-compliance incidents were identified during the fiscal year.

本集團同時鼓勵供應商促進企業社會責任活動和遵守企業社會責任活動和遵守企業社會責任守則與環境方面的法規。所有商務或見機不正當的利益均不能提供或接受;根據適用的法律法規,應定期披短有關的商業活動、結構、財務狀況和績效的信息。

B6. 產品責任

為保持本集團於其餐廳和會所業務 及物業管理業務之地位及持續發展, 本集團嚴格遵守行業之品質標準。 保障本集團之聲譽及公眾利益。 集團已嚴格遵守與產品和服務的健 康與安全、廣告、標籤及私隱有關之 法律及法規,並於本財政年度概無 發現有關之違規事件。

Quality Control

The Group is committed to providing superior and reliable services to its customers. The Group regularly reviews its service performance, policies and procedures, including the improvement of service quality, the maintenance of proper records, and the adequacy of staff training to ensure the provision of professional and attentive services and to safeguard the Company's reputation and the public interests.

As the Group's business nature does not involve product sales, there is no recall of goods for safety and health reasons, nor is there any recall procedure for products.

Customer Service Management

Customers are the cornerstone for the Group to achieve sustainable development and a source of power to promote product innovation. Therefore, customer satisfaction is one of our most important issues. The Group strictly requires that our products and services must conform to public interests, and handle inquiries and opinions of customers in a timely manner. 129 complaints have been received for the year ended 31 March 2023. All complaints will be recorded in detail for follow-up actions and future reference, so as to improve our service quality and pursue progress to meet customers' expectations.

Property Management Segment

The property management segment adopts the whole process customer service concept in project positioning, planning and management of its property management business in the mainland China, covers the customer satisfaction indicator of related operation units in all regions into the scope of performance evaluation on these operation units, and constantly improves our services in the interest of customers.

The Group conducts lawful management and operation in accordance with the requirements of government laws, regulations and policies, so as to ensure our property safety and value increase. By virtue of normative approaches and with the goal of pursuing the satisfaction of property owners, the Group provides efficient and superior services for the property owners, and satisfies their requirements honestly without fraud.


During the Financial Year, the property management segment received a total of 127 complaint cases regarding property management services. All complaints have been properly handled and resolved by the Customer Service Department. In addition, the Group did not receive any material non-compliance related to products and services.

In order to standardise and regulate customer services of operation units in various regions, the Group has formulated normative documents such as Property Owner's Complaints Handling Sheet, Standard Operating Procedures for Property Owner's Complaints Handling, etc. to constantly improve its customer relationship management level. In the future, the property management segment will continue to maintain good relationships with customers by providing superior services.

為了使各地區營運單位的客戶服務工作標準化及規範化,集團制定出《業主投訴回訪處理單》及《業主投訴處理標準作業規程》等制度主文件,持續提升其客戶關係管理水平。今後,物業管理分部將持續通過好份關係。

The lifestyle entertainment segment has established a membership system to provide more convenience and benefits for membership customers. All membership data are kept and encrypted by the membership database manager to avoid unauthorised access to the sensitive data of the members. 生活娛樂分部的會所業務設有會員制度,為加入了會籍的顧客提供更多的便利與優惠。所有已入會的會員資料均由會員經理保管並進行加密,確保沒有人在未經許可的情況下參閱會員的敏感資料。

The lifestyle entertainment segment is committed to providing customers with a safe and orderly environment within the club, to ensure that customers have a wonderful time there:

- Professional security personnel are hired to maintain the order within the club;

Closed-circuit television operates in the form of 24/7 (24 hours a day, 7 days a week), and in the event of an accident, we will view relevant records for follow-up;

- Strictly control the flow of club patrons;

The lifestyle entertainment segment has established rules to prevent drug abuse:

- Carry out conventional drug tests every month in the clubs, and choose random employees to receive sample tests;

- Any employee who is suspected of taking any prohibited drugs can be directly reported to his/her department supervisor;
- 如懷疑任何員工服用違例藥物,可直接向其部門主管報告;
- Our security personnel will request any person suspicious of dealing or taking any prohibited drugs to leave the club;
- 如懷疑任何人交易或服用違例藥物,保安人員會立即要求該人員離開;
- If any specific evidence is found to prove any person dealing or taking any prohibited drugs, the club manager will call the police immediately; and
- 如發現具體證據證明交易或服用違例藥物,會所經理會立即報警處理;及
- Arrange Caritas Lok Heep Club to provide lectures regularly with respect to drugs, mental health and other healthy lifestyle to employees.
- 定期安排明愛樂協會提供關於毒品、心理健康和其他健康生活的講座予 員工。

During the Financial Year, the lifestyle entertainment segment received a total of 2 complaint cases in relation to the quality of food and service. All complaints have been properly handled and resolved by the person in charge. Other than that, the lifestyle entertainment segment has not received any material noncompliance regarding products and services. In the future, the lifestyle entertainment segment will continue to maintain good relationships with customers by providing high-quality services, so as to improve its service quality and pursue improvement.

The Group recognises the importance of protecting intellectual property rights and reinforces the standards in the policies stated in the Code of Conduct. During the fiscal year, the Group did not experience any material infringement of intellectual property rights and has taken all reasonable measures to prevent any infringement of third parties' intellectual property rights.

Information confidentiality

The Group attaches great importance to the confidentiality of sensitive information. Every new employee is required to sign a confidentiality agreement and strictly abide by its terms to ensure that every employee understands the Group's confidentiality requirements for sensitive information, including customer information and trade secrets within the Group. The Group strictly prohibits any unauthorised disclosure to prevent information leakage from any direct or indirect means.

B7. Anti-Corruption

The Group understands the importance of anticorruption and integrity. Therefore, the Group prohibits any act of corruption, bribery, extortion, fraud or money laundering. The practice of good moral integrity and anti-corruption mechanism ensures the Group's acts in all work be professional, honest and fair.

The Group strictly abides by the Prevention of Bribery Ordinance, and requires all employees not to directly or indirectly provide, undertake, require or accept any illegitimate benefits, or carry out other dishonest acts in breach of good faith, law or national regulations in the course of business engagement, including criminal offences including corruption, bribery, extortion, fraud or money laundering, and other acts such as providing illegal political contributions, improper charitable donations or sponsorships, providing or accepting unreasonable gifts, entertainment or other illegitimate benefits, infringing business secrets, trademark rights, patent rights, copyrights and other intellectual property rights, engaged in unfair competition, etc. The Group requires that employees must report any benefits received, for which the Group will make the final decision on disposal.

資料保密

The Group has established a comprehensive anticorruption policy to strengthen business ethics, which includes strictly regulating the behaviour of employees, and encouraging the maintenance of good conduct, so that our employees understand the importance of upholding ethical conduct and practise it at work. As the cornerstone of the Group's culture of integrity, the Group requires all employees to be familiar with and strictly follow the established anti-corruption policies. Although the Group currently does not provide training related to anti-corruption for directors and employees, we still strive to enhance the importance of business ethics and anti-corruption concept of employees, and undertake to arrange relevant training in a timely manner to strengthen the practice of good corporate culture in the future when necessary.

In Financial Year 2022/23, neither the Group nor its employees were prosecuted for corruption, bribery, extortion, fraud or money laundering.

Whistle-Blowing Channel and Policy

The complaint whistleblower shall truthfully report the situation to the Administration Centre. Upon receipt of the whistleblowing matter, the Administration Centre will investigate the complaint. The Administration Centre will keep the whistleblower's personal information confidential, and will submit the case to the competent external agency for disposal when necessary. The whistleblower will undertake corresponding legal liability for fabricating facts, falsifying evidence, or conducting false charges or frame-ups by whistleblowing.

B8. Community Investment

The Group insists on the philosophy of giving back to the society. Apart from the continual and robust operation of business development, the Group will make active efforts to show the service spirit of our core corporate values, integrate the ideas of community concern and participation, and continue devoting to all kinds of education, cultural and social welfare activities.

As at 31 March 2023, the Group had fully utilised all such Net Proceeds for working capital of the Company, rental expenses and salary expenses of the lifestyle entertainment segment and partial repayment of the loan from the controlling shareholder.

SHARE OPTION SCHEME

Under the Share Option Scheme, the Board may offer to grant options to the following persons:

- (i) any full-time or part-time employees, executives, or officers of the Company or any of its subsidiaries;
- (ii) any Directors (including any non-executive Directors and independent non-executive Directors) of the Company or any of its subsidiaries;
- (iii) any advisers, consultants, suppliers, customers and agents to the Company or any of its subsidiaries; and
- (iv) such other persons who, in the sole opinion of the Board, will contribute or have contributed to the Group, the assessment criteria of which are:
 - (1) contribution to the development and performance of the Group;
 - (2) quality of work performed for the Group;
 - (3) initiative and commitment in performing his/her duties; and
 - (4) length of service or contribution to the Group.

During the year ended 31 March 2023, the Group recorded a segment loss of HK\$13.5 million in respect of the operation of clubbing business and restaurant and bar outlets. The current economic environment and prolonged impact of the COVID-19 pandemic since early 2020 and hence weak consumer sentiment in the clubbing and catering sectors have created uncertainties in relation to the financial performance of the Group's operation of clubbing businesses and restaurant and bar outlets. 1 GENERAL INFORMATION

AUX International Holdings Limited (the "Company") was incorporated in the Cayman Islands on 14 January 2013 as an exempted company with limited liability under the Companies Law (2013 Revision) (as consolidated and revised) of the Cayman Islands (the "Cayman Companies Law"). The Company and its subsidiaries (hereinafter collectively referred to as the "Group") is principally engaged in operation of clubbing business and restaurant and bar outlets, and provision of property management services and related value-added services.

2 SIGNIFICANT ACCOUNTING POLICIES

(a) Statement of compliance

These consolidated financial statements have been prepared in accordance with all applicable Hong Kong Financial Reporting Standards ("HKFRSs"), which collective term includes all applicable individual Hong Kong Financial Reporting Standards, Hong Kong Accounting Standards ("HKASs") and Interpretations issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA"), accounting principles generally accepted in Hong Kong and the disclosure requirements of the Hong Kong Companies Ordinance. These consolidated financial statements also comply with the applicable disclosure provisions of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Listing Rules"). Significant accounting policies adopted by the Group are disclosed below.

The HKICPA has issued certain amendments to HKFRSs that are first effective or available for early adoption for the current accounting period of the Group. Note 2(c) provides information on any changes in accounting policies resulting from initial application of these developments to the extent that they are relevant to the Group for the current accounting periods reflected in these consolidated financial statements.

The measurement basis used in the preparation of the consolidated financial statements is the historical cost basis

The preparation of consolidated financial statements in conformity with HKFRSs requires management to make judgements, estimates and assumptions that affect the application of policies and reported amounts of assets, liabilities, income and expenses. The estimates and associated assumptions are based on historical experience and various other factors that are believed to be reasonable under the circumstances, the results of which form the basis of making the judgements about carrying values of assets and liabilities that are not readily apparent from other sources. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

Judgements made by management in the application of HKFRSs that have significant effect on the financial statements and major sources of estimation uncertainty are discussed in note 3.

- Amendments to HKAS 37, Provisions, contingent liabilities and contingent assets: Onerous contracts – cost of fulfilling a contract

None of these developments have had a material effect on how the Group's results and financial position for the current or prior periods have been prepared or presented. The Group has not applied any new standard or interpretation that is not yet effective for the current accounting period.

(d) Subsidiaries and non-controlling interests

Subsidiaries are entities controlled by the Group. The Group controls an entity when it is exposed, or has rights, to variable returns from its involvement with the entity and has the ability to affect those returns through its power over the entity. When assessing whether the Group has power, only substantive rights (held by the Group and other parties) are considered.

An investment in a subsidiary is consolidated into the consolidated financial statements from the date that control commences until the date that control ceases. Intra-group balances, transactions and cash flows and any unrealised profits arising from intra-group transactions are eliminated in full in preparing the consolidated financial statements. Unrealised losses resulting from intra-group transactions are eliminated in the same way as unrealised gains but only to the extent that there is no evidence of impairment.

(c) 會計政策變動

Non-controlling interests represent the equity in a subsidiary not attributable directly or indirectly to the Company, and in respect of which the Group has not agreed any additional terms with the holders of those interests which would result in the Group as a whole having a contractual obligation in respect of those interests that meets the definition of a financial liability. For each business combination, the Group can elect to measure any non-controlling interests either at fair value or at the non-controlling interests' proportionate share of the subsidiary's net identifiable assets.

Non-controlling interests are presented in the consolidated statement of financial position within equity, separately from equity attributable to the equity shareholders of the Company. Non-controlling interests in the results of the Group are presented on the face of the consolidated statement of profit or loss and the consolidated statement of profit or loss and other comprehensive income as an allocation of the total profit or loss and total comprehensive income for the year between non-controlling interests and the equity shareholders of the Company.

Changes in the Group's interests in a subsidiary that do not result in a loss of control are accounted for as equity transactions, whereby adjustments are made to the amounts of controlling and non-controlling interests within consolidated equity to reflect the change in relative interests, but no adjustments are made to goodwill and no gain or loss is recognised.

When the Group loses control of a subsidiary, it is accounted for as a disposal of the entire interest in that subsidiary, with a resulting gain or loss being recognised in profit or loss. Any interest retained in that former subsidiary at the date when control is lost is recognised at fair value and this amount is regarded as the fair value on initial recognition of a financial asset or, when appropriate, the cost on initial recognition of an investment in an associate or joint venture.

In the Company's statement of financial position, an investment in a subsidiary is stated at cost less any impairment losses (see note 2(i)(ii)), unless the investment is classified as held for sale.

(e) Goodwill

Goodwill represents the excess of

- (i) the aggregate of the fair value of the consideration transferred, the amount of any non-controlling interest in the acquiree and the fair value of the Group's previously held equity interest in the acquiree; over
- (ii) the net fair value of the acquiree's identifiable assets and liabilities measured as at the acquisition date.

When (ii) is greater than (i), then this excess is recognised immediately in profit or loss as a gain on a bargain purchase.

Goodwill is stated at cost less accumulated impairment losses. Goodwill arising on a business combination is allocated to each cash-generating unit ("CGU"), or groups of CGUs, that is expected to benefit from the synergies of the combination and is tested annually for impairment (see note 2(i)(ii)).

On disposal of a CGU during the year, any attributable amount of purchased goodwill is included in the calculation of the profit or loss on disposal.

(f) Property, plant and equipment

Property, plant and equipment, including rightof-use assets arising from leases of underlying property, plant and equipment (see note 2(h)), are stated at cost less accumulated depreciation and impairment losses (see note 2(i)(ii)).

Depreciation is calculated to write off the cost of items of property, plant and equipment, less their estimated residual value, if any, using the straight-line method over their estimated useful lives as follows:

 Properties leased for own use Over the shorter of their economic useful life or terms of the leases

- Furniture, fixtures and equipment

2 to 10 years

Leasehold improvements

Over the unexpired term of leases

- Motor vehicles

3 to 5 years

Where parts of an item of property, plant and equipment have different useful lives, the cost of the item is allocated on a reasonable basis between the parts and each part is depreciated separately. Both the useful life of an asset and its residual value, if any, are reviewed annually.

Gains or losses arising from the retirement or disposal of an item of property, plant and equipment are determined as the difference between the net disposal proceeds and the carrying amount of the item and are recognised in profit or loss on the date of retirement or disposal.

(g) Intangible assets (other than goodwill)

Intangible assets that are acquired by the Group are stated at cost less accumulated amortisation (where the estimated useful life is finite) and impairment losses (see note 2(i)(ii)). Expenditure on internally generated goodwill and brands is recognised as an expense in the period in which it is incurred.

 Property management contracts and related customer relationships 10 years

Both the period and method of amortisation are reviewed annually.

(h) Leased assets

At inception of a contract, the Group assesses whether the contract is, or contains, a lease. A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration. Control is conveyed where the customer has both the right to direct the use of the identified asset and to obtain substantially all of the economic benefits from that use.

As a lessee

At the lease commencement date, the Group recognises a right-of-use asset and a lease liability, except for short-term leases that have a lease term of 12 months or less and leases of low-value assets. When the Group enters into a lease in respect of a low-value asset, the Group decides whether to capitalise the lease on a lease-by-lease basis. The lease payments associated with those leases which are not capitalised are recognised as an expense on a systematic basis over the lease term.

Where the lease is capitalised, the lease liability is initially recognised at the present value of the lease payments payable over the lease term, discounted using the interest rate implicit in the lease or, if that rate cannot be readily determined, using a relevant incremental borrowing rate. After initial recognition, the lease liability is measured at amortised cost and interest expense is calculated using the effective interest method. Variable lease payments that do not depend on an index or rate are not included in the measurement of the lease liability and hence are charged to profit or loss in the accounting period in which they are incurred.

The right-of-use asset recognised when a lease is capitalised is initially measured at cost, which comprises the initial amount of the lease liability plus any lease payments made at or before the commencement date, and any initial direct costs incurred. The lease liability is remeasured when there is a change in future lease payments arising from a change in an index or rate, or there is a change in the Group's estimate of the amount expected to be payable under a residual value guarantee, or there is a change arising from the reassessment of whether the Group will be reasonably certain to exercise a purchase, extension or termination option. When the lease liability is remeasured in this way, a corresponding adjustment is made to the carrying amount of the right-of-use asset, or is recorded in profit or loss if the carrying amount of the right-of-use asset has been reduced to zero.

Loss allowances for trade receivables are always measured at an amount equal to lifetime ECLs. ECLs on these financial assets are estimated using a provision matrix based on the Group's historical credit loss experience, adjusted for factors that are specific to the debtors and an assessment of both the current and forecast general economic conditions at the reporting date.

For all other financial instruments, the Group recognises a loss allowance equal to 12-month ECLs unless there has been a significant increase in credit risk of the financial instrument since initial recognition, in which case the loss allowance is measured at an amount equal to lifetime ECLs.

Significant increases in credit risk

In assessing whether the credit risk of a financial instrument has increased significantly since initial recognition, the Group compares the risk of default occurring on the financial instrument assessed at the reporting date with that assessed at the date of initial recognition. In making this reassessment, the Group considers that a default event occurs when (i) the borrower is unlikely to pay its credit obligations to the Group in full, without recourse by the Group to actions such as realising security (if any is held); or (ii) the financial asset is 90 days or 360 days past due depending on whether the financial asset is related to clubbing and restaurant and bar outlets operations or property management services. The Group considers both quantitative and qualitative information that is reasonable and supportable, including historical experience and forward-looking information that is available without undue cost or effort.

In particular, the following information is taken into account when assessing whether credit risk has increased significantly since initial recognition:

- failure to make payments of principal or interest on their contractually due dates:
- an actual or expected significant deterioration in a financial instrument's external or internal credit rating (if available);
- an actual or expected significant deterioration in the operating results of the debtor; and
- existing or forecast changes in the technological, market, economic or legal environment that have a significant adverse effect on the debtor's ability to meet its obligation to the Group.

Depending on the nature of the financial instruments, the assessment of a significant increase in credit risk is performed on either an individual basis or a collective basis. When the assessment is performed on a collective basis, the financial instruments are grouped based on shared credit risk characteristics, such as past due status and credit risk ratings.

ECLs are remeasured at each reporting date to reflect changes in the financial instrument's credit risk since initial recognition. Any change in the ECL amount is recognised as an impairment gain or loss in profit or loss. The Group recognises an impairment gain or loss for all financial instruments with a corresponding adjustment to their carrying amount through a loss allowance account.

Basis of calculation of interest income

At each reporting date, the Group assesses whether a financial asset is credit-impaired. A financial asset is credit-impaired when one or more events that have a detrimental impact on the estimated future cash flows of the financial asset have occurred.

Evidence that a financial asset is creditimpaired includes the following observable events:

- significant financial difficulties of the debtor:
- a breach of contract, such as a default or past due event;
- it becoming probable that the borrower will enter into bankruptcy or other financial reorganisation;
- significant changes in the technological, market, economic or legal environment that have an adverse effect on the debtor; or
- the disappearance of an active market for a security because of financial difficulties of the issuer.

Write-off policy

The gross carrying amount of a financial asset is written off (either partially or in full) to the extent that there is no realistic prospect of recovery. This is generally the case when the Group determines that the debtor does not have assets or sources of income that could generate sufficient cash flows to repay the amounts subject to the write-off.

Subsequent recoveries of an asset that was previously written off are recognised as a reversal of impairment in profit or loss in the period in which the recovery occurs.

(ii) Impairment of other assets

Internal and external sources of information are reviewed at the end of each reporting period to identify indications that the following assets may be impaired or, except in the case of goodwill, an impairment loss previously recognised no longer exists or may have decreased:

- property, plant and equipment, including right-of-use assets;
- intangible assets;
- goodwill; and
- investments in subsidiaries in the Company's statement of financial position.

If any such indication exists, the asset's recoverable amount is estimated. In addition, for goodwill, the recoverable amount is estimated annually whether or not there is any indication of impairment.

The recoverable amount of an asset is the greater of its fair value less costs of disposal and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset. Where an asset does not generate cash inflows largely independent of those from other assets, the recoverable amount is determined for the smallest group of assets that generates cash inflows independently (i.e. a CGU).

- Recognition of impairment losses

An impairment loss is recognised in profit or loss if the carrying amount of an asset, or the CGU to which it belongs, exceeds its recoverable amount. Impairment losses recognised in respect of CGUs are allocated first to reduce the carrying amount of any goodwill allocated to the CGU (or group of units) and then, to reduce the carrying amount of the other assets in the unit (or group of units) on a pro rata basis, except that the carrying value of an asset will not be reduced below its individual fair value less costs of disposal (if measurable) or value in use (if determinable).

In respect of assets other than goodwill, an impairment loss is reversed if there has been a favourable change in the estimates used to determine the recoverable amount. An impairment loss in respect of goodwill is not reversed.

A reversal of an impairment loss is limited to the asset's carrying amount that would have been determined had no impairment loss been recognised in prior years. Reversals of impairment losses are credited to profit or loss in the year in which the reversals are recognised.

Under the Listing Rules, the Group is required to prepare an interim financial report in compliance with HKAS 34, *Interim financial reporting*, in respect of the first six months of the financial year. At the end of the interim period, the Group applies the same impairment testing, recognition, and reversal criteria as it would at the end of the financial year (see notes 2(i)(i) and 2(i)(ii)).

Impairment losses recognised in an interim period in respect of goodwill are not reversed in a subsequent period. This is the case even if no loss, or a smaller loss, would have been recognised had the impairment been assessed only at the end of the financial year to which the interim period relates.

Inventories are assets which are held for sale in the ordinary course of business or in the form of materials or supplies to be consumed in the production process or in the rendering of services.

Inventories are carried at the lower of cost and net realisable value.

Cost is calculated using the first-in, first-out cost formula and comprises all costs of purchase and other costs incurred in bringing the inventories to their present location and condition.

Net realisable value is the estimated selling price in the ordinary course of business less the estimated costs of completion and the estimated costs necessary to make the sale.

When inventories are sold, the carrying amount of those inventories is recognised as an expense in the period in which the related revenue is recognised.

The amount of any write-down of inventories to net realisable value and all losses of inventories are recognised as an expense in the period the write-down or loss occurs. The amount of any reversal of any write-down of inventories is recognised as a reduction in the amount of inventories recognised as an expense in the period in which the reversal occurs.

(k) Contract liabilities

A contract liability is recognised when the customer pays non-refundable consideration before the Group recognises the related revenue (see note 2(s)). A contract liability would also be recognised if the Group has an unconditional right to receive non-refundable consideration before the Group recognises the related revenue. In such cases, a corresponding receivable would also be recognised (see note 2(l)).

存貨乃按成本及可變現淨值的較低 者列賬。

成本以先進先出成本方程式計算,並包括所有採購成本及將存貨運往 其現時地點及達至現狀時產生的其 他成本。

可變現淨值是指日常業務過程中的 估計售價減完成交易的估計成本及 進行銷售所需的估計成本。

倘存貨被出售,則該等存貨的賬面 值在相關收益獲確認的期間內確認 為支出。

任何存貨撇減至可變現淨值的金額 及存貨的所有虧損均在出現撇減或 虧損的期間內確認為支出。存貨的 任何撇減撥回金額均在出現撥回的 期間內確認為已確認為支出的存貨 金額減少。

A receivable is recognised when the Group has an unconditional right to receive consideration. A right to receive consideration is unconditional if only the passage of time is required before payment of that consideration is due.

Receivables are stated at amortised cost using the effective interest method and including an allowance for credit losses (see note 2(i)(i)).

(m) Interest-bearing borrowings

Interest-bearing borrowings are measured initially at fair value less attributable transaction costs. Subsequent to initial recognition, interest-bearing borrowings are stated at amortised cost using the effective interest method. Interest expense is recognised in accordance with the Group's accounting policy for borrowing costs (see note 2(u)).

(n) Trade and other payables

Trade and other payables are initially recognised at fair value and are subsequently stated at amortised cost unless the effect of discounting would be immaterial, in which case they are stated at invoice amounts.

(o) Cash and cash equivalents

Cash and cash equivalents comprise cash at bank and on hand, demand deposits with banks and other financial institutions, and short-term, highly liquid investments that are readily convertible into known amounts of cash and which are subject to an insignificant risk of changes in value, having been within three months of maturity at acquisition. Cash and cash equivalents are assessed for ECLs in accordance with the policy set out in note 2(i)(i).

(p) Employee benefits

(i) Short-term employee benefits

Salaries, annual bonuses, paid annual leave and the cost of non-monetary benefits are accrued in the year in which the associated services are rendered by employees. Where payment or settlement is deferred and the effect would be material, these amounts are stated at their present values.

(ii) Retirement benefits

Retirement benefits are provided by the Group under the Mandatory Provident Fund Scheme as defined contribution retirement plan in respect of the operations in Hong Kong. The employer's monthly contributions to the scheme are at a maximum of 5% of each employee's monthly salary, subject to a cap of monthly relevant income of \$30,000.

Contribution relating to the staff in the PRC are made to the PRC local retirement schemes pursuant to the relevant labour rules and regulations in the PRC.

The cost of all these schemes is charged to profit or loss of the Group for the years concerned and the assets of all these schemes are held separately from those of the Group.

Income tax for the year comprises current tax and movements in deferred tax assets and liabilities. Current tax and movements in deferred tax assets and liabilities are recognised in profit or loss except to the extent that they relate to items recognised in other comprehensive income or directly in equity, in which case the relevant amounts of tax are recognised in other comprehensive income or directly in equity, respectively.

Current tax is the expected tax payable on the taxable income for the year, using tax rates enacted or substantively enacted at the end of the reporting period, and any adjustment to tax payable in respect of previous years.

Deferred tax assets and liabilities arise from deductible and taxable temporary differences respectively, being the differences between the carrying amounts of assets and liabilities for financial reporting purposes and their tax bases. Deferred tax assets also arise from unused tax losses and unused tax credits.

Apart from certain limited exceptions, all deferred tax liabilities, and all deferred tax assets to the extent that it is probable that future taxable profits will be available against which the asset can be utilised, are recognised. Future taxable profits that may support the recognition of deferred tax assets arising from deductible temporary differences include those that will arise from the reversal of existing taxable temporary differences, provided those differences relate to the same taxation authority and the same taxable entity, and are expected to reverse either in the same period as the expected reversal of the deductible temporary difference or in periods into which a tax loss arising from the deferred tax asset can be carried back or forward. The same criteria are adopted when determining whether existing taxable temporary differences support the recognition of deferred tax assets arising from unused tax losses and credits, that is, those differences are taken into account if they relate to the same taxation authority and the same taxable entity, and are expected to reverse in a period, or periods, in which the tax loss or credit can be utilised.

The amount of deferred tax recognised is measured based on the expected manner of realisation or settlement of the carrying amount of the assets and liabilities, using tax rates enacted or substantively enacted at the end of the reporting period. Deferred tax assets and liabilities are not discounted.

The carrying amount of a deferred tax asset is reviewed at the end of each reporting period and is reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow the related tax benefit to be utilised. Any such reduction is reversed to the extent that it becomes probable that sufficient taxable profits will be available.

Additional income taxes that arise from the distribution of dividends are recognised when the liability to pay the related dividends is recognised.

Provisions are recognised when the Group or the Company has a legal or constructive obligation arising as a result of a past event, it is probable that an outflow of economic benefits will be required to settle the obligation and a reliable estimate can be made. Where the time value of money is material, provisions are stated at the present value of the expenditure expected to settle the obligation.

Possible obligations, whose existence will only be confirmed by the occurrence or non-occurrence of one or more future events are also disclosed as contingent liabilities unless the probability of outflow of economic benefits is remote.

(s) Revenue and other income

Income is classified by the Group as revenue when it arises from the sale of goods or the provision of services in the ordinary course of the Group's business.

The Group is the principal for its revenue transactions and recognises revenue on a gross basis. In determining whether the Group acts as a principal or as an agent, it considers whether it obtains control of the products before they are transferred to the customers. Control refers to the Group's ability to direct the use of and obtain substantially all of the remaining benefits from the products.

Further details of the Group's revenue and other income recognition policies are as follows:

(a) Revenue from contracts with customers

Revenue is recognised when control over a product or service is transferred to the customer at the amount of promised consideration to which the Group is expected to be entitled, excluding those amounts collected on behalf of third parties such as value added tax or other sales taxes. Revenue is after deduction of any trade discounts.

The Group takes advantage of the practical expedient in paragraph 63 of HKFRS 15 and does not adjust the consideration for any effects of a significant financing component if the period of financing is 12 months or less.

Sale of food and beverages, tobacco products, living consumption and festive products

Revenue from sale of food and beverages, tobacco products, living consumption and festive products is recognised when the customer takes possession of and accepts the products.

For financial assets measured at amortised cost that are not credit-impaired, the effective interest rate is applied to the gross carrying amount of the asset. For credit-impaired financial assets, the effective interest rate is applied to the amortised cost (i.e. gross carrying amount net of loss allowance) of the asset (see note 2(i)(i)).

(ii) Government grants

Government grants are recognised in the consolidated statement of financial position initially when there is reasonable assurance that they will be received and that the Group will comply with the conditions attaching to them. Grants that compensate the Group for expenses incurred are recognised as income in profit or loss on a systematic basis in the same periods in which the expenses are incurred.

(t) Translation of foreign currencies

Foreign currency transactions during the year are translated at the foreign exchange rates ruling at the transaction dates. Monetary assets and liabilities denominated in foreign currencies are translated at the foreign exchange rates ruling at the end of the reporting period. Exchange gains and losses are recognised in profit or loss.

The results of foreign operations are translated into Hong Kong dollars ("HKD") at the exchange rates approximating the foreign exchange rates ruling at the dates of the transactions. Statement of financial position items, including goodwill arising on consolidation of foreign operations acquired are translated into HKD at the closing foreign exchange rates at the end of the reporting period. The resulting exchange differences are recognised in other comprehensive income and accumulated separately in equity in the exchange reserve.

On disposal of a foreign operation, the cumulative amount of the exchange differences relating to that foreign operation is reclassified from equity to profit or loss when the profit or loss on disposal is recognised.

(u) Borrowing costs

Borrowing costs that are directly attributable to the acquisition, construction or production of an asset which necessarily takes a substantial period of time to get ready for its intended use or sale are capitalised as part of the cost of that asset. Other borrowing costs are expensed in the period in which they are incurred.

The capitalisation of borrowing costs as part of the cost of a qualifying asset commences when expenditure for the asset is being incurred, borrowing costs are being incurred and activities that are necessary to prepare the asset for its intended use or sale are in progress. Capitalisation of borrowing costs is suspended or ceases when substantially all the activities necessary to prepare the qualifying asset for its intended use or sale are interrupted or complete.

Key sources of estimation uncertainty are as follows:

(a) Impairment of property, plant and equipment

If circumstances indicate that the carrying value of a property, plant and equipment may not be recoverable, the asset may be considered impaired, and an impairment loss may be recognised in profit or loss. These property, plant and equipment are tested for impairment whenever events or changes in circumstances indicate that their recorded carrying amounts may not be recoverable, except for goodwill which is tested on an annual basis. When a decline of the assets' recoverable amounts below the carrying amounts has occurred, the carrying amount is reduced to the recoverable amount.

The recoverable amount is the greater of the fair value less costs of disposal and value in use. It is difficult to precisely estimate fair value less costs of disposal because quoted market prices for the Group's assets are not readily available. In determining value in use, expected cash flows generated by the asset are discounted to their present value, which requires significant judgement relating to level of sales volume and amount of operating costs. The Group uses all readily available information in determining an amount that is a reasonable approximation of the recoverable amount, including estimates based on reasonable and supportable assumptions and projections of sales volume and amount of operating costs.

(b) Impairment of trade and other receivables

In measuring ECLs for trade and other receivables, the Group takes into account reasonable and supportable information that is available without undue cost or effort. This includes information about past events, current conditions and forecasts of future economic conditions. The amount of ECLs is sensitive to changes in circumstances and forecast economic conditions.

The Group's primary objectives when managing capital are to safeguard the Group's ability to continue as a going concern, so that it can continue to provide returns for shareholders and benefits for other stakeholders, by pricing products and services commensurately with the level of risk and by securing access to finance at a reasonable cost.

The Group actively and regularly reviews and manages its capital structure to maintain a balance between the higher shareholder returns that might be possible with higher levels of borrowings and the advantages and security afforded by a sound capital position, and makes adjustments to the capital structure in light of changes in economic conditions.

The Group monitors capital with reference to its debt position. The Group's strategy was to maintain the equity and debt in a balanced position and ensure there was adequate working capital to service its debt obligations. The ratio of the Group's total liabilities over its total assets at 31 March 2023 was 57% (2022: 60%).

Neither the Company nor any of its subsidiaries are subject to externally imposed capital requirements.

Exposure to credit, liquidity, interest rate and currency risks arises in the normal course of the Group's business. The Group's exposure to these risks and the financial risk management policies and practices used by the Group to manage these risks are described below.

Credit risk refers to the risk that a counterparty will default on its contractual obligations resulting in a financial loss to the Group. The Group's credit risk is primarily attributable to trade receivables. Management has a credit policy in place and the exposure to this credit risk is monitored on an ongoing basis.

Trade receivables

The Group's exposure to credit risk is influenced mainly by the individual characteristics of each customer rather than the industry or country in which the customers operate. There are no significant concentrations of credit risk within the Group, as where there is credit exposure to the Group, it is spread over a diversified portfolio of customers.

The Group's exposure to credit risk arising from trade receivables in connection with operation of clubbing business and restaurant and bar outlets is limited because the counterparties are financial institutions, for which the Group considers to have low credit risk.

In respect of trade receivables relating to the provision of property management services, individual credit evaluations are performed on customers requiring credit over a certain amount. These evaluations focus on the customer's past history of making payments when due and current ability to pay, and take into account information specific to the customer as well as pertaining to the economic environment in which the customer operates.

The Group measures loss allowances for trade receivables at an amount equal to lifetime ECLs, which is calculated using a provision matrix.
